The Minister of Law (Shri A. K. Sen): (a) and (b). The model scheme for legal aid to the poor was prepared for the guidance of the State Governments, who are primarily concerned with its implementation, and was discussed in the Conference of Law Ministers held recently. The scheme is under further consideration in the light of those discussions.

As regards the washery, though the report has been accepted, it has been decided not to implement the project, because it will be uneconomic to do so, having regard to the washability characteristics of the coal and other attendant factors. The project report in respect of the underground mines is still awaited.
