Census of Chinese in India

Will the Minister of Home Affairs be pleased to state:

- (a) whether the census of Chinese mationals living in India has been completed;
- (b) if so, their number and the number of the Chinese living in India who hold passports issued by the Kuomintang regime; and
- (c) how many of them have sought Indian citizenship?

The Minister of Home Affairs (Shri. G. B. Pant): (a). Yes.

- (b) The number of registered Chinese nationals as on 1st. August, 1960 was 12,373; of these 3601 held K.M.T. passports.
- (c) Government of India have received 66 applications.

- Shri D. C. Sharma: May I know if any break-up of the number of Chinese living in different places in India is available? If so, how many of them are living in Calcutta?
- Shri G. B. Pant: In West Bengal, the number came to 8,336.
- Shri D. C. Sharma: May I know if any watch is kept on the activities of these Chinese, because it has been criticised on the floor of the House and in the papers that some of them, while carrying on their avocations like dentistry, hotel-keeping....

An Hon. Member: Laundry business.

- Shri D. C. Sharma: and other things, carry on espionage work?
- Shri G. B. Pant: One may assume that the Government are watchful.
- Shri P. K. Deo: In view of the fact that the Kuomintang Government is not recognised by the Government of India, may I know if the 3600 Chinese are being treated as stateless persons? If so, what action are Government taking for the continuance of their stay in this country?
- Shri G. B. Pant: They are being treated a stateless persons, but they have been given permits to stay on for a year.
- Dr. Ram Subhag Singh: May I know whether at the time of taking the census the period of stay of these Chinese in India was also noted. If co, how many of them came to India after 1950 and how many of such Chinese were asked to quit India due to espionage activity?
- Shri G. B. Pant: 34 have been asked recently to leave the country. But these figures are not related to the

year 1950. Till 1943, all those who came were allowed to stay on and there was no system of registration. Those who came after 1943 were registered. Now, a census has been taken of all of them, whether they came before or after 1943.

Shri Tridib Kumar Chaudhuri: May I know if it is known to the Government that a large number of Chinese have been living in Calcutta, in places like China Town inside the city itself, for generations? Have these people also been registered as Chinese nationals simply because of their origin or have they declared themselves as Chinese nationals?

Shri G. B. Pant: Some of them—those who had been living here for a long time—have already acquired the right of citizenship of India under the Constitution.

श्री गो० ब० पन्त : वे बहुत से काम करते हैं। श्रापने कलकत्ता में देखा होगा श्रीर दूसरी जगहों में देखा होगा। जूते बनाने का काम करते हैं श्रीर दूसरी बहुत सी तरह के काम करते हैं। लांडरीज उनकी बहुत जगह हैं तथा दूसरी तरह के श्रीर भी छोटे मोटे ऐसे काम हैं जो ये करते हैं। कुछ का किसी दल से ताल्लुक हो सकता है।

Shri P. K. Deo: May I know whether this figure of 12,000 includes the Tibetan refugees who have lately come to India, and whether they are considered as Chinese nationals?

Shri 'G. B. Pant: No, they are not included in this figure.

Dr. Ram Subhag Singh: May I know whether Government any report from the Government of West Bengal saying that a Chinese has purchased a very big tea garden in village Padong in the Kalimpong subdivision of Darjeeling district? If so, what action is being taken in that regard?

Shri G. B. Pant: I am thankful to the hon. Member for giving me that information. I myself had no knowledge of it so far.

Shri Tangamani: We were told that out of the 12,373 Chinese registered here, 3,601 came with no passports. May I know whether the remaining 8,700 hold Chinese passports or they are also persons from Kuomintang holding no passports?

Shri G. B. Pant: As I said, 3,601 hold KMT passports. But of the remainder, there are many who came here with the passports of the Chinese Republic previously, and some of them have been residing here for a long time.

Shri D. C. Sharma: Is it a fact that some of these Chinese supported India's stand with regard to the Chinese incursions into India? If so, what was their number and whether Government have received any memorandum from them on the subject?

Shri G. B. Pant: Yes, I have seen reports to the effect that some of them have ostensibly done so. I cannot give their exact number.
