in this House that I did not feel satisfied with the reduction of 10 per cent announced by the Millowners' Federation. They have recently announced other reductions. I must say that we are still studying it. In fact, their proposals are fairly complicated, and I would like to study them further before expressing any opinion.

श्वी विभूति मिश्र : ग्रमी शास्त्री जी ने कहा कि दस फीसदी घटेगी । उस के बाद बाजार में ग्रगर देखें तो खादी के कपड़े के द.म बढ़ गये हैं ग्रौर गरीबों को कपड़ा खरीदना मुक्तिल हो गया है तो मैं जानना चाहता हूं कि क्या सरकार कोई जबर्दस्त कदम उठायेगी कि कपड़े ग्रौर खादी की कीमत घटे?

श्री लाल बहादुर शास्त्री : जहां तक दस फीसदी घटाने की बात है वह तो घटी ही हैं। अलबत्ता मेरे कहने के बाद यह ऐलान उन्होंने किया है कि वह उस को ग्रीर घटायोंगे ग्रीर उन्होंने ग्रलग ग्रलग कपडों की क्वालिटी के हिसाब से दाम घटाये हैं। मैं ने यह कहा ग्रौर मैं खैर इसको स्वोकार नहीं करता हूं कि उस के बाद पिछले पांच, छैदिन के अन्दर दाम बढे हैं लेकिन मैं ने यह कहा कि जो उन्होंने ऋब ऐलान किया है उस पर मैं अपनी राय अभी जाहिर करने के लिये तैयार नहीं हूं जब तक कि में उसे पूरी तरह से देख न ल क्योंकि मझे इतमीनान होना चाहिए कि जो उन्होंने घटाया है वह दरग्रसल १० फीसदी से ज्यादा है।

## Trade Agreement with Indonesia

\*500. Shri Pangarkar: Will the Minister of Commerce and Industry be pleased to state:

(a) whether Government have considered the proposal for the renewal of trade agreement with Indonesia as the same has expired on the 30th June, 1960; and

(b) if so, the result thereof?

The Deputy Minister of Commerce and Industry (Shri Satish Chandra): (a) and (b). The question of revision of the Trade Agreement has been taken up with the Indonesian Government and is being actively pursued.

Shri Pangarkar: Is it a fact that Indian trade with Indonesia declined during 1959; if so, what is the reason?

Shri Satish Chandra: There was a sudden decline in 1957. As far as 1959 is concerned, the trade was more than in the previous year.

## State Trading Corporation

\*492. Shri Vidya Charan Shukla: Will the Minister of Commerce and Industry be pleased to state what is the criterion for selection of Commodities for trading adopted by the State Trading Corporation?

The Minister of Commerce (Shri Kanungo): A commodity is selected for trading by the State Trading Corporation when it is considered that such trading by a large organisation on a bulk basis as for promotional purposes is advantageous, e.g., better foreign exchange earnings in respect of exports and stabilisation of internal prices and or assured supplies of essential raw materials to actual users.

## **Transistor Radio Sets**

Will the Minister of Commerce and Industry be pleased to state:

(a) whether it is proposed to manufacture transistor radio sets in our country from next year;
