

(b) if so, what percentage of components will have to be imported and the average annual expenditure of foreign exchange likely to be involved; and

(c) whether the transistor equipments manufactured in Bharat Electronics Limited, Bangalore will also supply components of such radio sets?

**The Minister of Industry (Shri Manubhai Shah):** (a) Yes, Sir.

(b) It is estimated that cost of imported content in a transistor radio set will be upto 25 to 30 per cent. of its ex-factory price and the average annual expenditure of foreign exchange in this regard is likely to be Rs. 20 to Rs. 30 lakhs out of a total allocation of about Rs. 1 crore incurred for the radio receiver manufacturing industry at present.

(c) Bharat Electronics Limited, Bangalore are not manufacturing components for such radio sets at present but they are going to manufacture radio valves and tubes.

#### Accommodation for Industrial Workers

Will the Minister of Works, Housing and Supply be pleased to state:

(a) whether Government have taken decision to permit construction of hostels for non-family industrial workers under the subsidised Industrial Housing Scheme; and

(b) if so, the details thereof?

**The Deputy Minister of Works, Housing and Supply (Shri Anil K. Chanda):** (a) Yes. The decision was communicated to the State Governments on the 29th February, 1960.

(b) A note on hostel type accommodation for housing non-family industrial workers is laid on the Table of the Lok Sabha. [See Appendix II, annexure No. 36].

#### Export of Mica

\*503. **Shri Bibhuti Mishra:** Will the Minister of Commerce and Industry be pleased to state:

(a) whether it is a fact that the Mica Export Promotion Council has recommended to the Government of India for banning shipment of mica on consignment basis and allowing shipment only against letters of credit; and

(b) if so, Government decisions thereon?

**The Deputy Minister of Commerce and Industry (Shri Satish Chandra):** (a) Yes, Sir.

(b) Due to conflicting opinions on the subject, the Mica Export Promotion Council was asked to ascertain the views of the various Associations representing Mica export trade.

क्या सूचना और प्रसारण मंत्री यह बताने की कृपा करेंगे कि :

(क) क्या सरकार उन गैर-सरकारी निर्माताओं को जो गांधीवादी सिद्धांतों जैसे हिन्दू-मुस्लिम एकता, अस्पृश्यता निवारण, अहिंसा आदि पर आधारित चलचित्र तैयार करते हैं, कोई सहायता देती है ; और

(ख) यह सहायता किस रूप में दी जाती है ?

**सूचना और प्रसारण मंत्री (डा० केसकर) :** (क) और (ख). इस समय सरकार के सामने कोई ऐसी योजना नहीं है जिसके अन्तर्गत निर्माताओं को गांधी जी के सिद्धांतों पर फिल्में बनाने के लिये मदद दी जाए। एक दो विशेष फिल्मों को छोड़ कर चलचित्र (Feature films)

तैयार करने के लिये सरकार निर्माताओं को कोई आर्थिक सहायता नहीं दे रही है।

अल्बत्ता, सरकार विचार कर रही है कि छूपा-छूत दूर करने के लिये फिल्मों का उपयोग क्योंकर किया जाय। छूपा-छूत के विषय में एक चलचित्र (Feature film) बनाने के लिये हम ऋण के रूप में सहायता दे रहे हैं। इस विषय पर कुछ छोटी फिल्में बनाये जाने का भी विचार हमारे सामने है। अगर यह तय कर लिया गया कि ऐसी फिल्में बनाई जायें तो निर्माताओं की मुनासिब सहायता की जायेगी।

**"Carry-over" Investment from Second Five Year Plan**

Will the Minister of Planning be pleased to state the break-up of the estimated carry-over investment from the Second to the Third Five Year Plan?

**The Deputy Minister of Planning (Shri S. N. Mishra):** The total investment on projects under execution at the end of the Second Plan remaining to be undertaken mainly during the Third Plan is estimated at Rs. 1800 crores. This includes about Rs. 800 crores under industries and transport and about Rs. 700 crores under irrigation and power.

**Exodus of Pakistanis to India**

Will the Prime Minister be pleased to state:

(a) whether it is a fact that the exodus of Pakistanis from West Pakistan to India has greatly increased in recent months; and

(b) if so, the causes of the same?

**The Parliamentary Secretary to the Minister of External Affairs (Shri Sadath Ali Khan):** (a) By "exodus" the Hon. Member presumably refers to the recent increase in visits from West Pakistan and not to migration from there. Visitors from West Pakistan to India have considerably increased during the past year.

(b) One of the reasons is the liberal visa policy we are pursuing in our desire to improve understanding between the peoples of the two countries.

**Annual Conferences in Srinagar during Summer**

Will the Prime Minister be pleased to state:

(a) whether any instruction was issued to all the Ministries and Chief Ministers for not holding Annual Conferences in Srinagar during summer; and

(b) if so, whether any conference was cancelled after the issue of this instruction?

**The Parliamentary Secretary to the Minister of External Affairs (Shri Sadath Ali Khan):** (a) and (b). The Prime Minister wrote a letter in June last to the Ministers of the Central Government and to Chief Ministers of State Governments that the holding of big conferences in the Jammu and Kashmir State involved a heavy burden on the Government of that State. He suggested, therefore, that such conferences should normally not be held in that State. As a result of this, it was decided that two conferences which were to have been held at Srinagar would be held in Delhi and Bombay instead.
