scheduled operators, a warning has been issued to one and action to be taken is under consideration in the rase of the other.

#### **Corpse** in Train

\*678. Shri D. C. Sharma: Will the Minister of Railways be pleased to refer to the reply given to Starred Question No. 957 on the 18th March, 1960 and state:

(a) the progress made so far in the arrest of the person responsible for the death of a 16-year old boy whose body was found packed in a box by the Railway police in a third class compartment of Bareilly passenger train at Agra on the 1st March, 1960; and

(b) if so, the action taken against him?

The Deputy Minister of Irrigation and Power (Shri Hathi): (a) No State Government has, so far, recast its long-range flood control plan, so as to bring it in conformity with the recommendations of the High Level Committee on Floods. The Government of Jammu & Kashmir have, however, prepared a master plan for the Kashmir Valley generally on the lines indicated by the Committee.

(b) The master plan for the Kashmir Valley has been examined by the Central Water and Power Commission.

(c) Yes, Sir.
