**Shifting of Offices from Delhi**

Will the Minister of Works, Housing and Supply be pleased to state:

(a) how many Central Government Offices have been shifted from the Capital to various parts of the country to relieve shortage of office accommodation in the Capital;

(b) how much office accommodation has been released as a result of the shifting of offices outside Delhi so far;

(c) which Government offices are going to be shifted from the Capital to outside places within the financial year 1960-61; and

(d) how much office accommodation shall be released as a result of the shifting of offices from the Capital during the financial year 1960-61?

**The Deputy Minister of Works, Housing and Supply (Shri Anil K. Chanda):** (a) Eleven—Since 1958.

(b) Above 95,000 square feet.

(c) Agricultural Labour Enquiry Division of the Ministry of Labour and Employment. No final decision has so far been taken to shift any other office outside Delhi during the remaining part of the year 1960-61.

(d) 20,742 square feet by the 15th September, 1960 (including 16,843 square feet belonging to Northern Railway).
