Employees' Provident Fund Act

*692. **Shri P. K. Deo:** Will the Minister of Labour and Employment be pleased to state:

(a) whether the Central Board of Trustees of the Employees Provident Fund approached the Central Government to extend the Act to all industries;

(b) at present which are the industries that do not come under this Act; and

(c) what are Government's reactions to the recommendation of the Central Board of Trustees of the Employees' Provident Fund?

The Deputy Minister of Labour (Shri Abid Ali): (a) No; the Board recommended that as many industries as possible should be brought under the Act.

(b) At present 47 industries are covered under the Act. Of these 39 are mentioned in the annual report. The remaining 8 are:

1. Mica Factories;
2. Mica Mines;
3. Plywood factories;
4. Automobile repairing and servicing industry;
5. Cane farms owned by sugar factories;
6. Rice milling;
7. Flour milling; and
8. Dal milling.

(c) More industries are covered from time to time.

Small Scale Industries

*693. **Shri Damani:** Will the Minister of Commerce and Industry be pleased to state:

(a) whether Government have taken any decision to reorganise various

Government departments relating to small scale industries; and

(b) if so, the details thereof?
