- (a) whether the Union Ministry of Labour has initiated a move to persuade more industrial establishments to set up joint management councils; and
 - (b) if so, the result thereof?

The Deputy Minister of Planning and Labour and Employment (Shri L. N. Mishra): (a) Yes.

(b) It is too early to assess the results.

Tibetan Refugees

*39. Shrimati IIa Palchoudhuri: Shri Subiman Ghose: Shri Hem Barua: Shri Aurobindo Ghosal: Shri Indrajit Gupta: Shrimati Renu Chakravartty:

Will the **Prime Minister** be pleased to state:

- (a) whether it is a fact that about 600 Tibetan fled recently with their flocks of sheep numbering about 1500 from the Chinese-occupied area of Ladakh into Indian territory;
- (b) if so, full facts about the matter; and
- (c) the steps taken by Government in connection with these Tibetan refugees?

The Deputy Minister of External Affairs (Shrimati Lakshmi Menon):

(a) and (b). The total number of refugees who have entered Ladakh from Tibet between March-April, 1959 and September, 1960 is 648. Most of them have brought their livestock with them.

(c) Some of them have found employment on road construction work in Ladakh. Others have been moved away from the border and settled with their livestock on land in Ladakh itself.

Cement Machinery

*40. Shri Shree Narayan Das:

Will the Minister of Commerce and Industry be pleased to state:

- (a) whether it is a fact that the firms which manufacture cement machinery within the country are unable to cope with the demand; and
- (b) if so, what steps have been taken or are proposed to be taken to meet this situation?

The Minister of Industry (Shri Manubhai Shah): (a) and (b). There are at present six firms registered or licensed under the Industries (Development and Regulation Act), 1951, for the manufacture of cement machinery and parts thereof. Of these, three units are licensed for the manufacture of cement machinery with a turnover of about Rs. 4 crores worth including complete of machinery cement plants, per annum. It is expected that when these three units also go into production by the end of 1962, as anticipated, much of the country's demand for cement machinery would be met. About 5 to 6 standard cement plants of tons day capacity will be manufactured in the country every year from 1963 onward. It is the policy of the Gov-ernment to encourage creation of additional capacity to meet the demand for machinery either by expansion of the existing units or by the licensing of new units.

- (c) The number of temporary posts on 1st April, 1960 was 9645. There are no semi-permanent posts However, persons are granted semi-permanent status after two years' continuous service. This entitles them to some restricted leave concessions.
- (d) Information regarding number of temporary posts which have been in existence for three years or more is being collected.
