STATEMENT

The Patna University had failed to assure that they would extend necessary facilities for the establishing and running of an Industrial Estate at their University. In its place, it has now been proposed to establish the same in Allahabad University. It has also been decided on the advice of the Director of Industrial Estates, Central Small Scale Industries Organisation, that the proposed establishment of the Industrial Estate at Utkal University be dropped for the present and that in its place Baroda University be selected. Schemes from Universities of Osmania and Rajasthan have been received which are under scrutiny of the Central Small Scale Industries Organisation.
