- (i) the collection of stratospheric particulate material for the study of (a) stratospheric distribution of particulate ærosols and environmental radioactivities of natural and artificial origin, and (b) interhemispherical and troposphere-stratosphere mixing and calculations;
- (ii) the observation of primary cosmic rays by means of photographic emulsions and electronic counters to study their origin and energies; and
- (iii) the determination of other meteorological parameters simultaneously with the above observations, namely, stratospheric wind velocities and patterns, pressure-altitude, temperature, humidity and ozone concentration.
- (c) Hyderabad in Andhra Pradesh.

## Burglary at Gauhati Radio Station

Will the Minister of Information and Broadcasting be pleased to state:

- (a) whether it is a fact that a burglary has been committed at the Gauhati Radio Station on the night of the 3rd December, 1960; and
- (b) if so, the amount of loss and the action the Government have taken or propose to take?

The Minister of Information and Broadcasting (Dr. Keskar): (a) and (b). A burglary took place at the Gauhati Station of All India Radio on the early morning of 2nd December, 1960 and the safe which contained Rs. 12,790.27 nP. was taken away by the burglars. Immediate intimation was given to all concerned including the Police who have succeeded in apprehending the culprits and recovering most of the stolen property.

Security arrangements at the Radio Station, which is a little out of the town are being reconsidered. The All India Radio authorities had drawn the attention of the police sometime back to the necessity of an armed guard at the Station.

## Export of Cloth to Ceylon

The details of the restrictions are not yet available. Our High Commission in Colombo has taken up the matter with the Ceylon Government.
