(d) whether the contract has been renewed for another three years?

The Minister of Transport and Communications (Dr. P. Subbarayan): (a) No. Sir.

(d) Yes, beyond 31-12-1960.

Tampering with Railway Track near Maniharighat

•1071. Shri P. C. Borooah: Will the Minister of Railways be pleased to state:

(a) whether fish-plates from the railway track near Maniharighat were found to have been removed on the night of the 3rd December, 1960;

(b) whether there was any serious accident averted by the timely discovery of the removal of fish-plates;

(c) who was responsible for their removal; and

(d) whether the gangman who averted the accident is being suitably rewarded?

The Deputy Minister of Railways (Shri S. V. Ramaswamy): (a) Yes, Sir.

Stoppage of Booking on S.E. Railway

Haldia-Khargpur Line

***1073. Shri Indrajit Gupta:** Will the Minister of Railways be pleased to state:

(a) whether about 2,000 villages in the Midnapore District of West Bengal have been notified on the 17th November, 1960 in connection with the proposed construction of the Khargpur-Haldia rail link;

(b) whether the inhabitants of these notified villages are to be evicted in future; and

(c) if so, whether any programme for phasing of the operation and compensation for those affected has been prepared?
