ORAL ANSWERS TO QUESTIONS

Forged Passport Cases in Punjab

\*1833. Shri Ram Krishan Gupta: Will the Prime Minister be pleased to state:

- (a) whether prosecutions and trials are now going on in Punjab for forged passports;
- (b) if so, the total number of trials and persons under prosecution; and
- (c) what steps are being taken to prevent such forging?

The Parliamentary Secretary to the Minister of External Affairs (Shri Sadath Ali Khan): (a) Yes.

- (b) Twenty-two cases involving ninety-one persons, in connection with forgeries in passports, are pending trial in the Punjab.
- (c) to obviate the possibility of photographs being replaced on passports, the photographs are embossed and perforated with official stamp. As far as perforation is concerned, some of the Passport Issuing Authorities are following this practice. Action is under way for supplying perforating machines to all Passport Issuing Authorities. A proposal is under study to use eyelet machines for punching eyelets on the corners of photographs on passports. In addition to these measures, strict checking of travel documents has been enforced at the 479 (Ai) LS-1.

points of exit and Special Police staff has been posted in the Punjab.

Shri Ram Krishan Gupta: May I know whether any new cases have also been registered recently?

Shri Sadath Ali Khan: Some cases have come to our notice and action is being taken. Some arrests have been made and the cases are under investigation.

Shri Ram Krishan Gupta: May 1 know whether it is a fact that some travel agencies of the Punjab are also involved in these cases, and if so, whether they are still recognised?

Shri Sadath Ali Khan: Yes, they are involved in these cases. In fact, some who are responsible for these are standing trial.

Shri Tyagi: Were the persons who have been prosecuted acting as individuals or were they acting together as a group working in a conspiracy?

The Prime Minister and Minister of External Affairs (Shri Jawaharlal Nehru): In a big organisation like this, there is bound to be group working. It was, no doubt, more like a conspiracy.

Shri D. C. Sharma: No, no.

श्री जवाहरलाल नेहरू : अभी तक इंग्लैंड में काफी तादाद में ऐसे लोग पड़े हैं, और जब जब मैं पिछले दो तीन वर्षों में वहां गया हूं, वे मेरे पास आये हैं ताकि हम उनको पासपोर्ट दे दें । उन्होंने पासपोर्ट मांगा और अपनी हालत बतलाई । बात ऐसी है कि कुसूर उतना अनुका नहीं था जितना उन लोगों का जिन्होंने उनको एक्स्पलायट किया था । अब वे वहां रह कर ऐसी हालत में हो जाते हैं कि वे न इंडियन नैशनल्स हैं न और । स्टेटलेस हो जाते हैं । इस बात पर हम गौर कर रहे हैं और कुछ लोगों को आयद हमारे यहां पासपोर्ट मिले भी ।

Dr. Vijaya Ananda: May I know which other States are involved in this? May I also know the names of those States?

Shri Sadath Ali Khan: Recently some arrests were made in Madras. Madras is one of the places. Kerala also is there. I do not have the list of the other places.

Shri Jawaharlal Nehru: Most these people were stopped from going by the measures we took at the airports. It was really by air that they used to go. Then they made special arrangements to go by ship from Cochin. We were caught napping because we had not thought that they would engage a special ship from Cochin to take them. So hundreds went. It was then that this matter came to a head. They were stopped at Rome, Paris and elsewhere. Some were sent back; some still are there. These trials are as a result of that par icular effort.

Shri N. R. Muniswamy: May I know whether the officers who were conniving at this and were abettors in this were also proceeded against?

Shri Jawaharlal Nehru Naturally, I do not know about any particular officer, but whoever has been found guilty is being proceeded against.

Shri Narayanankutty Menon: Are Government aware that a number of travel agencies in Kerala were concerned with this and were actually conniving at this passport racket? If so, has any action been taken against those travel agencies who are recognised by the Government of India?

Shri Jawaharlal Nehru: Action has been taken against some travel agencies. I do not know about the Kerala ones. But as regards those who were here in Delhi and Punjab, action has been taken against them.

Shri Ram Krishan Gupta: May I know whether these cases are investigated and conducted by the Punjab police or whether separate arrangement has been made under the control of the Central Government?

Shri Jawaharlal Nehru: I could not answer that. But obviously both of them are involved, that is, the Punjab

police and the Central Intelligence and investigation agency. I think they are working in close contact with each other.

## Fertilizer Plant at Trombay

Will the Minister of Commerce and Industry be pleased to state the upto-date progress so far made in setting up the fertilizer plant at Trombay?

The Deputy Minister of Commerce and Industry (Shri Satish Chandra): A statement is laid on the Table of the Sabha. [See Appendix VI annexure No. 45].

Shri Pangarkar: In reply to a starred question, it was stated the US Government had offered \$28.00 million to meet the rupee expenditure of the factory. May I know whether any amount has been given so far from that?

Shri Satish Chandra: Yes, a loan of \$30:00 million dollars has been promised....

Shri Pangarkar: Under PL 480....

Mr. Speaker: What is the meaning of talking to each other like that? The hon. Member will speak louder.

Shri Pangarkar: In reply to a reply to a previous question, it was stated that \$28.00 million were offered by the US Government. May I know whether any amount has been given so far by the US Government?

Mr. Speaker: Has any amount been received?

Shri Satish Chandra: I am saying that the US Development Loan Fund has promised us a loan of \$30.00 million. It will be drawn as and when payments are made to the foreign contractors for the supply of plant and machinery. The Indian expenditure will be met from the counterpart funds accumulated in India under PL 480. That money will be drawn as and when the necessity arises.

श्री मं ला० दिवेदी: मैं जानना चाहता हं कि यह जो ३ करोड़ रूपया का ऋण ग्रमरीका से मिला है, उस के भ्रलावा भारत सरकार क्या खर्च करेगी. श्रीर जो ५२४ एकड जमीन हासिल की गई है उसके ऊपर सरकार को क्या व्यय पड़ा है ?

श्री सतीश चन्द्र : सभी खर्च सरकार करेगी। यह ऋण मिलेगा जो भ्रदा करना होगा मय सूद के।

श्री म० ला० दिवेदी : मैंने यह पुछा कि कल कितनी लागत इस में लगेगी, प्रलाव। म्रमरीका के रुपये के जो कि मिला है। भीर साइट खरीदने पर किसना रूपया खर्च किया गया ?

भी सतीश चन्द्र: ग्रन्दाज है कि इस प्रोजेक्ट में कुल २५ करोड़ ६० लगेगा, जिसमें फोरन एक्स्चेन्ज का खर्च करीब ११ करोड़ रु होगा। ध्रमरीका से ऋषा के रूप में जो सहायता मिली है वह कूल इस प्रोजेक्ट के लिये खर्च होगी धौर वह काफी होगी। लेकिन वह सब रुपया गवर्नमेंट म्राफ इंडिया का होगा भीर ऋण के रूप में मिलेगा।

श्री म० ला० दिवेदी: साइट पर निसा खर्च होगा ?

श्री सतीश चन्द्र : माइट का सर्च धभी नहीं मालूम हुधा क्योंकि धभी पूरा ऐक्विजिशन नहीं हुआ है। ६२५ एक इ. में स ५०० एकड़ जमीन मिली है, कुछ्बम बई गवर्न-मेंट की है जिसके लिये उन्होंने कहा है कि हम इस्तेमाल कर सकते हैं, लेकिन दाम धभी तय नहीं हए हैं। काम जारी हो गया है।

Shri T. B. Vittal Rao: May I know what is the amount that will be paid to the Burmah-Shell refineries for taking their refinery gas?

Shri Satish Chandra: Payment to the Burmah-Shell for refinery gas will be made on the basis of the calorific value and will be equivalent to the calorific value or the heat con-
