18th November, 1960, as the grant of any retrospective effect would have created difficulties in regard to employees who had already retired from service. Such persons would have been required to refund the Government share of contribution together with interest thereon to their Contributory Provident Fund Accounts, in case they had chosen to be governed by the Liberalised Pension Rules in pace of the Contributory Provident Fund Rules which were, otherwise, applicable to them.

## U.K. Bank Rates

The Deputy Minister of Finance (Shrimati Tarkeshwari Sinha): (a) The U.K. Chancellor of the Exchequer announced on the 25th July, 1961, the raising of the British Bank Rate from 5 per cent. to 7 per cent. with effect from the 26th July, 1961.
(b) There may be some increase in the rates of interest payable on the loans which India will receive from the U.K. for the Third Five Year Plan, so long as the bank rate is not reduced.

## World Children's Festival, Moscow

Will the Minister of Steel, Mines and Fuel be pleased to state:
(a) whether it is a fact that the shortage of billets has affected tise production of re-rolling mills in Maharashtra, Punjab, Gujarat, Madras, U.P. and West Bengal;
(b) what is the estimated loss in production; and
(c) what steps have been taken to provide necessary billets to these rerolling mills?

The Minister of Steel, Mines and Fuel (Sardar Swaran Singh): (a) to (c). Billets supplies from the integrated steel works were affected during the months of May and June, 1961. This was partly due to the conversion of more of the available steel into urgently required products like rails and partly due to periodical overhauls to rolling mills which are taken up from time to time. Supplies have improved since.

I should, however, state that supplies of billets will not in future be as plentiful as it was during the year 1960. Inconvenient and relatively uneconomic as it is for integrated steel works to produce billets for sale, it was provided in the Second Plan that from towards the end of the Plan the integrated steel works would make available 630,000 tons of billets a year to the re-rolling industry. The year 1960 was however one of relative plenty from the point of view of availability of billets. The main reason for this was that the finishing milis in the integrated steel works in Bhilai and Durgapur had not come into regular production. With the commissioning of the finishing mills, more and more of billets are now being used within the integrated steel works and from now on it is unlikely that the re-rolling industry will receive from the integrated steel works very much more than what had been originally planned-about 50,000 to 60,000 tons of billets a month.

As Hon'ble Members know, in the programme of development of the steel industry in the Third Plan, it is envisaged that the integrated steel works will, after expansion, supply an additional about 350,000 tons of billets a year. Of this, about 150,000 tons will go to new re-rolling mills which are being allowed to be put up in relatively unserved areas. The balance will be used to augment supplies to existing re-rolling mills.
