Will the Minister of Steel, Mines and Fuel be pleased to refer to the reply given to Starred Question No. 1163 on the 4th September, 1961 and state:

(a) whether Government have since taken any decision on the project recommended for utilisation of Naharkatiya natural gas;

(b) by when the plants for manufacture of furnace black, polyethylene and Cis-4-Polybutadiene are expected to go into production; and

(c) what is the estimated quantum of the associated and non-associated gases from Naharkatiya ollfields which have already gone to waste because of non-utilisaticn?

The Minister et Mines and Oil (Shri K. D. Malaviya): (a) The recommendations made by the Expert Committee on the utilisation of Naharkatiya natural gas were accepted by Government.

(b) The furnace black plant is expected to go into production by the end of 1962 or early 1963. No firm date for the completion of the polycthylene and Cis 4-Polybutadiene plants can be given at this stage.

(c) The quantity of associated and non-associated gases flared since the incorporation of Oil India Limited *i.e.* 18th February 1959 is as follows:--

STATEMENT

During the Second Plan period, the Government of India undertook a scheme for the establishment of Special Employment Exchanges for the physically handicapped. Such Exchanges have so far been established in Bombay, Delhi and Madras.

Moreover instructions have been issued to normal Employment Exchanges to the effect that they should offer special assistance to physically Instructions handicapped registrants. have also been issued that handicapped persons examined and certified as fit by Medical Boards attached to Special Employment Exchanges for the Physically Handicapped should not be subjected to a further medical examination by the employing departments

Ordnance Factory, Kanpur

*690. Shri D. C. Sharma: Will the Minister of Defence be pleased to state:

(a) the progress made so far in the proposal to expand the Ordnance Factory, Kanpur;

(b) the details of the expansion programme; and

(c) the production during 1960-61 as compared to 1959-60?

The Deputy Minister of Defence (Shri Raghuramaiah): (a) There is no proposal to extend the size of the Ordnance Factory premises at Kanpur. However, a project report for setting up of an alloy and special steel plant prepared by the Director-General of Ordnance Factories has now been received and is under consideration of Government. This will be a separate factory.

(b) The proposal is to set up a plant of capacity for 50,000 tons of alloy and special steels annually.

(2) The production in the Ordnance Factory, Kanpur, has increased during 1960-61 as compared to 1959-60 by about 11 per cent.
