(c) A provision of Rs. 21,000 is proposed in the budget for 1962-63.

Will the **Prime Minister** be pleased to state:

- (a) whether any charges of a criminal nature have been framed against the Naga rebel leader Phizo, a fugitive from Indian justice, at present in London;
- (b) whether these charges have been communicated to the Government of U.K.; and
 - (c) if so, what is their response?

The Deputy Minister of Affairs (Shrimati Lakshmi Menon):
(a) to (c). A warrant of arrest against Phizo on a charge of conspiracy to murder his colleague, Sakhrie, is still in force.

The Government had informed the U.K. High Commission in New Delhi that Phizo was a fugitive from our justice and that, although, for the present, we were not asking for his extradition, we hoped that, while he was in the U.K. territory, he would not be allowed to induige in activities directed against India.

Phizo has since then been granted U.K. citizenship on the basis of his Indian citizenship. We have, however, informed the U.K. authorities that we reserved the right to ask for his extradition if there was a need to do so. We have, of course, no intention, for the present, to ask for his extradition.
