Port at Haldia

*97. Shri Indrajit Gupta: Will the Minister of Transport and Communications be pleased to refer to reply given to the starred question No. 393 on the 11th August 1961 and state:

(a) whether the development of a subsidiary port at Haldia is now conditional on the World Bank's approval of the project;

(b) the detailed reasons for nonacceptance by the World Bank of the project report prepared by the experts of th Calcutta Port Commissioners;

(c) whether the engineering and hydraulic studies asked for by the World Bank have commenced;

(d) if so, when they are likely to be completed; and

(e) the amount of foreign exchange required for carrying out these studies?

The Minister of State in the Ministry of Transport and Communications (Shri Raj Bahadur): A statement is laid on the table of the Sabha.

STATEMENT

(a) and (b). The development of Haldia as a satellite port has been included in the Third Five Year Plan. The World Bank has appreciated the need for a satellite port and has noted that Haldia is the best site available but considers that an up-to-date hydraulic Research Department should be set up to study in greater detail the hydraulic problems of the Hoogly and the estuary and in particular the practicability of maintaining deep water alongside the proposed satellite port site and in its approaches in respect of which they consider that fur-ther data should be collected. The Bank also considers that expensive engineering works at the site should be undertaken only after further clarification on the hyrdraulic aspects of the site and its approaches is available.
