## Dislocation of Train Services during September, 1961

Will the Minister of Railways be pleased to state:

- (a) whether train services were dislocated in September, 1961 on Itarsi-Bhusaval and Itarsi-Nagpur sections;
- (b) if so, how many trains were cancelled from different stations; and
- (c) the arrangements made for alternative travel for the passengers?

The Deputy Minister of Railways (Shri S. V. Ramaswamy): (a) Yes, Sir

- (b) Fifteen trains were cancelled including one short of destination. Ten Mails and Expresses were terminated at convenient junction stations short of the sections on which breaches had occurred and worked back as corresponding Up/Down trains.
- 62 Passenger trains were cancelled on the affected sections, these services being run as regular services on the rest of their scheduled runs.
- (c) Long distance trains between Delhi and Madras, Delhi and Bombay and between Bombay and Howrah (via Allahabad) which were not cancelled were diverted via alternative routes as available. On two occasions, viz. on 16th September, 1961 and 19th September, 1961 combined duplicate 1377 (Ai) L.S.D.—3.

Grand Trunk Express and Janta Express trains were run from Nagpur to Madras.

## Hirakud Reservoir

- (a) whether any enquiry was made in respect of the flood-controlling capacity of the Hirakud Reservoir;
- (b) if so, what is the finding of this Enquiry; and
