Starred Question No. 229 on the 9th August, 1961 regarding World Bank's Aid for Third Five Year Plan and state:

(a) whether any progress has since been made in connection with the talks with the World Bank regarding the remaining projects; and

(b) if so, the details thereof?

The Deputy Minister of Finance (Shri B. R. Bhagat): (a) Yes, Sir.

(b) The two agreements referred to in the reply to the earlier question were signed on August 9 and August 17, 1961, under which loans of \$35 million and \$21 million, respectively, are available for development of coal industry in the private sector and the Calcutta Port. Copies of these agreements have since been placed in the Parliament Library. In addition to these two agreements, an agreement for a loan of \$50 million for Indian Railways was also signed on October 13, 1961. Copies of this agreement will be placed in the Parliament Library as soon as they become available. Of the remaining projects which are still under consideration, negotiations have started recently in Washington for a loan for power development in the D.V.C. area.

(ख) प्रावश्यक संगठन बनाने का काम पूरा किया जा रहा है। यह काम इस प्रकार का नहीं है कि यह किसी कठोर तंत्र में जकड़ा जा संक ।

(ग) सम्भवतः प्रश्न के इस भाग का म्राशय संसद् में पेश किये जाने वाले विघेयकों से हैं। यदि ऐसी बात है तो प्रायोग से उचिन समय पर यह अनुरोध किया जायेगा कि वह भावी केन्द्रीय विघेयक और साथ साय ही उनके हिन्दी अनुवाद किये जाने की व्यवस्था के सम्बन्ध में सरकार को परामर्श दे।

Rourkela Steel Plant

*176. Shri M. B. Thakore: Will the Minister of Steel, Mines and Fuel be pleased to state:

(a) whether it is a fact that production of iron and steel at Rourkela Steel Plant has fallen considerably;

(b) if so, the details thereof; and

(c) whether it is a fact that it was due to the non-availability of ladles used for taking out molten matter from the two blast furnaces and that was also because of shortage of wagons?

The Minister of Steel, Mines and Fuel (Sardar Swaran Singh): (a) and (b). There has not been any considerable fall in production of iron and

steel at Rourkela as will be evident from the following figures:

- (iii) dislocation in slag dumping yard due to heavy rains.

Cheap Text-books on Technical Subjects

•177. Shri Hem Barua: Shri Bibhuti Mishra: Shri B. L. Dwivedi: Shri S. C. Samanta: Sardar Iqbal Singh: Shri Chuni Lal:

Will the Minister of Education be pleased to refer to the reply given to Starred Question No. 232 on the 9th August, 1961 and state:

(a) whether Government have since finalised the details of the scheme of production and distribution of cheaper editions of text-books dealing with technical subjects; and

(b) if so, the details thereof?

The Minister of Education (Shri K. L. Shrimali): (a) and (b). In principle the Scheme has been finalised, but the details are still being worked out. On the basis of certain broad, guiding principles, the publication of titles has begun. One book "College Chemistry" by Linus Pauling is on sale at Rs. 12.50 as against the original price of \$6:75 i.e. Rs. 30.00.

A Joint Indo-American Board has been constituted and has met once on 4th November, 1961. It will meet at regular intervals and will go into the problems connected with the working of the Scheme, particularly with a view to safeguarding the interests of Indian authors and publishers.

Oil Drilling in Private and Public Sectors
