(c) whether any new development plans are being implemented to further this work in the existing all-India research institutions?

The Minister of Industry (Shri Manubhai Shab): (a) The Central Scricultural Research Station, Berhampore (West Bengal) was established in 1943 by the Central Government. Three more Sericultural Research Stations have been set upduring the Second Five Year Plan period by the State Governments, with financial assistance from the Centre.

- (b) These stations are located at Channapatna in Mysore, Titabar in Assam and Chaibasa in Bihar.
- (c) An expansion scheme at an estimated cost of Rs. 22 lakhs was sanctioned in 1960 for the Central Sericultural Research Station, Berhampore, and is at present under implementation. Besides, the Central Silk Board has recently constituted a Central Research Coordination Committee for making recommendations regarding the organisation and development of sericultural research in the The Committee has since country. submitted its report and the Committee's recommendations on the set up of research stations are under consideration by the Silk Board.

Will the **Prime Minister** be pleased to state:

- (a) whether it is a fact that the Indian traders in Tibet are facing discrimination specially in the matter of facilities for exchange, resulting in huge accumulation of Chinese currency with them;
- (b) whether the Government are aware that Indian merchants are compelled to dispose of the Chinese currency at lower rates and have to suffer great loss; and

(c) the steps taken to protect them?

The Parliamentary Secretary to the Minister of External Affairs (Shri Sadath Ali Khan): (a) Yes, Sir, it is a fact that Indian traders in Tibet are not normally given exchange facilities.

- (b) The Government of India are aware that Indian merchants have been compelled to dispose of their holdings of Chinese currency at lower rates and thereby suffer a loss.
- (c) The Government of India have requested the Chinese Government to permit customary trade between India and Tibet to continue in terms of the letter and spirit of the Sino-Indian Agreement of 1954. This would include normal remittance facilities.
