(c) A statement giving the actual exports of iron ore to different countries during the financial of 1961-62 is placed on the Table of the House. [See Appendix I, annexure No. 13] A slight increase in the total exports is anticipated for 1962-63, the pattern of exports broadly remaining the same.

#### Sino-Nepal Boundary Treaty

\*75. **Shri Agadi:** Will the **Prime Minister** be pleased to refer to the reply given to Starred Question No. 212 on the 24th November, 1961 and state:

(a) whether the maps attached to the Sino-Nepal Boundary Treaty regarding tri-Junctions of Nepal, India and Tibet have been studied;

(b) if so, the comments of the Government of India thereon; and

(c) the action taken?

**The Deputy Minister of External Affairs (Shrimati Lakshmi Menon):**  
(a) Yes Sir.

(b) The Government of India have no reason to believe that the two tri-junctions with which they are concerned have in any way been erroneously depicted. The Treaty as well as the alignment shown on the maps attached to it broadly follow the traditional high water-shed boundary with minor mutual adjustments.

(c) No action on the part of Government is considered necessary.

#### Houses on Hire-purchase

\*78. **Shrimati Ila Palchoudhuri:** Will the **Minister of Works, Housing and Supply** be pleased to state:

(a) whether a scheme to build houses in Delhi for allotment on hire-purchase system is under Government's consideration;

(b) if so, brief details thereof, including its financial implications;

(c) the progress made in connection therewith; and

(c) when it is likely to be finalised and implemented?

**The Minister of Works, Housing and Supply (Dr. B. Gopala Reddi):** (a) No.

(b) to (d). Do not arise.

#### Manufacture of Watches

\*80. **Shri P. C. Borooah:** Will the **Minister of Commerce and Industry** be pleased to state:

(a) the extent to which watches have been manufactured in the public and the private sectors in the year 1961; and

(b) how far the imports of watches and their spare parts had been reduced in that year as compared to the preceding year?

**The Minister of Industry (Shri Manubhai Shah):** (a) and (b). The construction of the factory buildings for the Watch factory in Bangalore which commenced on the 27th August 1961, is expected to be completed by November 1962. All the machinery required for the watch factory has been ordered and is expected to be received by the end of September 1962.

The first batch of 52 trainees selected by the Japanese experts were sent to Japan in July 1961 and most of them will be returning to Bangalore after completion of their training by July/August 1962. The second batch of 50 trainees will be sent to Japan for training after the return of the first batch.

The first stage of actual manufacture of components etc. with 54 per cent indigenous content is expected to commence in January 1963. The indigenous content will go upto 85 per cent to 90 per cent in the fourth stage of production which is expected to be completed by the end of December, 1966.

To impart training to Indian technicians, assembly of watches from imported movements commenced from July 1961. Assembling of the first batch of about 15,000 watches will be completed by the end of March 1962. 11,465 watches consisting of 1,870 Ladies' (Sujata) 4815 Gents' (Citizen) and 4780 Gents' (Janata) have been assembled till about the middle of February 1962.

The second unit at Bombay in the private sector has started assembling watches. Their actual output will be known after a few months of working.

Imports are being allowed under a restricted import policy.

#### Manufacture of Cloth, Paper and Rayon

87. Shri N. M. Deb: Will the Minister of Commerce and Industry be pleased to state whether Government propose to manufacture the following during the Third Five Year Plan;

- (i) cloth from bamboo;
- (ii) paper from jute sticks; and
- (iii) rayon from bamboo?

The Minister of Industry (Shri Manubhai Shah): (i) No, Sir.

(ii) and (iii). Recently a scheme for the production of paper from Jute stick has been approved. Several schemes for the production of Rayon pulp from bamboo have been approved. These are likely to go into production during the current plan period.

#### Indian Statistical Institute

88. Shri N. M. Deb: Will the Prime Minister be pleased to state whether it is a fact that Centre has taken over Indian Statistical Institute and it will be shifted to Delhi?

The Prime Minister and Minister of External Affairs (Shri Jawaharlal Nehru): No, Sir.

#### Indian Journalists asked to Quit Nepal

89. Shri P. G. Deb: Will the Prime Minister be pleased to state:

(a) whether the reporter of the *Hindustan Times*, New Delhi was served with a notice to quit Nepal recently; and

(b) if so, the action taken in the matter?

The Prime Minister and Minister of External Affairs (Shri Jawaharlal Nehru): (a) Yes, Sir. The Government of Nepal ordered Shri V. R. Mohinder of the *Hindustan Times* to leave Nepal, as his presence was considered by them to be undesirable for the present.

(b) The Government of India have considered it unnecessary to intervene on this occasion.

#### Arms recovered from Goan soldiers

90. Shri P. G. Deb: Will the Prime Minister be pleased to state:

(a) whether it is a fact that some of the arms recovered from the Portuguese Goan white soldiers in Goa bore marks of N.A.T.O.; and

(b) if so, the details of the same?

The Prime Minister and Minister of External Affairs (Shri Jawaharlal Nehru): (a) and (b). The arms recovered in Goa do not bear any NATO markings although it is understood that some of them are in use by NATO forces. Some of the ammunition boxes have NATO markings.

#### Marine Diesel Engines

91. Shrimati Ila Palchoudhuri: Will the Minister of Commerce and Industry be pleased to state:

(a) whether it is a fact that a scheme for setting up a plant for manufacturing marine diesel engines for ships is under the consideration of the Government of India;

(b) if so, details thereof; and

(c) the progress made in connection therewith?
