hon. Home Minister says that it must go to the Planning Commission. There is no harm. It will certainly be taken up tomorrow. Even if it is late I will allow it to be taken up as early as possible.

WRITTEN ANSWERS TO QUES-TIONS

Nunmati Refinery

*275. Shri P. C. Borooah: Will the Minister of Steel, Mines and Fuel be pleased to state:

(a) whether it is a fact that the Nunmati refinery has gone into production;

(b) if so, when and what is the total amount of crude oil refined at the refinery so far; and

(c) whether it is now working at its full capacity and what is the production capacity installed there?

The Minister of Mines and Oil (Shri K. D. Malaviya): (a) and (b). Trial production has commenced from 26th December, 1961. About 67,000 tons were processed upto 28th February, 1962.

(c) The refinery is not yet working to full capacity. The installed capacity is 0.75 million tons per annum.

Indian Soldiers in Congo

*276. { Shri D. C. Sharma: Shri P. C. Borooah:

Will the Minister of Defence be pleased to state:

(a) the number of Indian soldiers serving at present in Congo under the U.N. Command and those killed or wounded so far;

(b) the number of wounded who have been repatriated and who are being treated at the U.N. Hospital in Leopoldville;

(c) whether any other personnel have been sent there in place of those who died in the operation; and

(d) if so, the details thereof?

The Deputy Minister of Defence (Shri Raghuramaiah): (a) The number of Indian Armed Forces personnel serving in Congo under U.N. Command before the recent turn-over commenced was 5,803. 15 of our personnel have been killed and 83 wounded in action in Congo.

(b) 44 of the wounded personnel were repatriated to India. None of the wounded is at present receiving treatment at the U.N. Hospital in Leopoldville.

(c) and (d). 2 officers, 3 JCOs. and 39 Other Ranks have been despatched to Congo as replacement of casualities.

Oil Exploration in Assam

*280. Shri Morarka: Will the Minister of Steel, Mines and Fuel be pleased to state:

(a) whether it is a fact that Government is considering a proposal to enter into some sort of drilling contract with some foreign firms for the expeditious oil exploration in Assam; and

(b) if so, with what results?

The Minister of Mines and Oil (Shri K. D. Malaviya): (a) The Government have entered into an Agreement with Ente Nazionale Idrocarburi (ENI), Italy, which, *inter-alia*, includes a scheme for contract drilling in Assam under the supervision of the Oil and Natural Gas Commission,

(b) Drilling under the Contract has not yet commenced and details are being worked out.

Fire in Kurasia Mines

*285. Shri T. B. Vittal Rao: Will the Minister of Steel, Mines and Fuel be pleased to state: (b) if so, the nature of decision arrived at by Government;

(c) whether there is any prospect of working the mines in the near future; and

(d) what is the amount of loss sustained so far by the National Coal Development Corporation?

The Minister of Steel, Mines and Fuel (Sardar Swaran Singh): (a) and (b). The finding of the Committee is that the cause of the fire was spontaneous heating, and that steps taken to deal with the fire, after it was discovered, were in the right direction. Government have agreed with these findings.

(c) Yes; recovery operations are under way, and it is expected that, if these operations are not interrupted for unavoidable reasons, the mine will restart working in June, 1962.

(d) There has been no major loss of machinery or other equipment. It is also not likely that the coal standing on the pillars has been damaged to any great extent. However, a correct assessment of the position about loss can be made only after the mine is fully recovered.

Coal Dump in Kanpur and Ahmedabad

*288. Shri P. C. Borooah: Will the Minister of Steel, Mines and Fuel be pleased to state:

(a) whether a coal dump has been set up for the textile industry in Kanpur;

(b) if so, what is the extent of the reserve kept in the dump and when it was created; and

(c) whether a similar dump has also been created for the textile mills in Ahmedabad?

The Minister of Steel, Mines and Fuel (Sardar Swaran Singh); (a) and (b). No coal dump has been set up for the textile industry at Kanpur. But at a recent meeting held on February 12, 1962, between the Coal Controler and the major consumers of coal in Kanpur, including representatives of the textile industry, it was decided that a Consumers' Co-operative pool for the purpose of procurement of coal and its distribution should be set up at Kanpur, and that the individual units participating in the pool should draw their supplies from it.

(c) There is no dump for textile mills at Ahmedabad either. But a similar pool system is working there also.

Revision of Compounded Levy Scheme for Vegetable Oil Industry

*291. Shri Morarka: Will the Minister of Finance be pleased to state:

(a) whether the vegetable oil industry has made representations for the revision of the compounded levy for the development of the industry; and

(b) if so, what action has been taken in the matter?

The Deputy Minister of Finance (Shri B. R. Bhagat): (a) Yes, Sir.

(b) The question is under consideration.

Proscription of a book "Chin ki Jhalak"

*292. Shri D. C. Sharma: Will the Minister of Home Affairs be pleased to state:

(a) whether it is a fact that the Government of Bihar have proscribed a Hindi book, entitled "Chin ki Jhalak" published by the Foreign Language Publications, Peking;

(b) whether it is also a fact that the book contains two maps on its inner cover, which shows the whole of NEFA and parts of Jammu and Kashmir, Himachal Pradesh, U.P. and Bhutan as belonging to China;
