at the last Indo-Pakistan trade review talks held at Karachi in December, 1961, the Government of Pakistan made an offer to export 10,000 tons of brick burning coal per month to Northern parts of India. The question whether the proposal is feasible is under examination.

Durgapur Steel Plant

*297. Shri P. C. Borocah: Will the Minister of Steel, Mines and Fuel be pleased to state:

- (a) whether it is a fact that the No. 3 coke oven battery at the Durgapur Steel Project has been commissioned;
 - (b) if so, when;
- (c) what was the cost involved in its installation; and
- (d) how far the processing capacity of the plant has been increased by its installation?

The Minister of Steel, Mines and Fuel (Sardar Swaran Singh): (a) and (b). The third coke oven battery at Durgapur Steel Project has been lighted up in two parts on 31st January, and 14th February, 1962. Coke production is expected to start by 15th April. 1962.

- (c) On pro-rata basis, the cost of the third coke oven battery is about Rs. 27 million, excluding the cost of general services which form a separate item under the contract with Messrs. Indian Steel Works Construction Company Ltd., London.
- (d) When this battery goes into full production, it will produce coke for the third blast furnace.

(स) और अधिक सर्वेक्षण किया जा रहा है और विदेशों से विंड इलेक्ट्रिक जनरेटर प्राप्त किये जा रहे हैं। सरकारी और अधै-सरकारी संगठनों को तकनीकी सलाह और मदद देने के अलावा नेशनल रिसर्च डेवलपमेंट कार्पोरेशन से यह भी कहा गया है कि वह विंड पावर डिवीजन द्वारा विकसित की गई पवन चिक्कयों के व्यापारिक उत्पादन के लिये फर्मों को उत्साहित करे।

Directorate of Practical Training for Mining Students

*299. Shri T. B. Vittal Rao: Will the Minister of Scientific Research and Cultural Affairs be pleased to state:

- (a) whether the Directorate of Practical Training for Mining Students has since been set up;
- (b) what is the scope and duration of practical Training for Diploma holders; and

 - (vi) whether people's representatives will be associated with the administrator even in report of such departments,

- (d) by what time is the report of the Asoke Sen Committee expected and how long will it take for the Government to implement the same?
