to duty as the judgment is awaited. It is not possible to indicate when departmental action will be finalised.

(b) The lacuna is that Bellier's Turbidity test by Evers method (Acetic Acid) is not specifically mentioned in the rules and the test cannot, therefore, be legally applied detect the adulteration of mustard oil with groundnut oil.

(c) No. Sir. Necessary steps however, being taken to amend relevant rule in the Prevention Food Adulteration Rules, 1955.

Acquisition of Ships during Second Five Year Plan

Rural Credit

It has also agreed to advance loans to Co-operative Banks on the repledge of goods at ½ per cent below the usual rate. This scheme has been introduced recently and it is too early to assess its progress.

The Minister of Irrigation and Power (Shri S. K. Patil): The investigations at Gudari in Orissa upstream of the proposed site at Gotta have been recommended by the Central Water and Power Commission to the

Government of Andhra Pradesh. The Government of Andhra Pradesh have written to the Government of Orissa to give their concurrence to the investigation of the alternative site at Gudari and also permit their officials to enter the Orissa territory for carrying out the surveys.

Janata Express between Calcutta and Bombay

*507. Shri Supakar: Will the Minister of Railways be pleased to state:

- (a) whether there is any proposal to run a Janata Express train between Calcutta and Bombay via Nagpur to relieve the congestion of passenger traffic in mail and passenger trains between the two termini; and
- (b) if so, when the proposal will materialise?

The Deputy Minister of Railways (Shri Shahnawaz Khan): (a) and (b). There is no such proposal. However, the two existing passenger trains running between Howrah and Nagpur have been strengthened by two bogies each to provide relief.

- (a) whether any abnormal features in weather conditions have been noted during the last one year;
- (b) if so, whether any investigation has been made in respect of them; and

The Minister of State in the Ministry of Transport and Communications (Shri Humayun Kabir): (a) No, Sir.

(b) and (c). Do not arise.

Turmeric

*509. { Shri Ball Reddy: Shri B. S. Murthy:

Will the Minister of Food and Agriculture be pleased to state:

(a) the reason for the fall in price of turmeric; and (b) the position regarding foreign markets for turmeric?

The Deputy Minister of Food and Agriculture (Shri A. M. Thomas): (a) The fall in prices of turmeric appears to have been caused by a sharp increase in production from 137,502 tons in 1954-55 to 155,660 tons in 1955-56. Internal demand for turmeric being relatively inelastic, a substantial increase in output has resulted in a more than proportionate fall in prices.

(b) Indian turmeric is in increasing demand in foreign markets on the whole. A statement showing the exports of turmeic is laid on the table of the Sabha. [See Appendix III, annexure No. 33.]

Chemical Fertilizers

*510. Shri S. V. Ramaswamy: Will the Minister of Food and Agriculture be pleased to state:

- (a) what is the quantity of chemical fertilizers consumed in 1955-56 as compared to previous two years;
- (b) whether there is any method of knowing as to how those have been used in the production of food stuffs and in the production of cash crops; and
- (c) what steps have been taken to increase the output of compost and green manures?

The Deputy Minister of Food and Agriculture (Shri A. M. Thomas): (a) to (c). A statement is laid on the Table of the Sabha. [See Appendix III, annexure No. 34.]

Hospet-Guntakal Railway Line

*511. Shri B. S. Murthy: Will the Minister of Railways be pleased to state:

- (a) whether the Hospet-Guntakal line and the yard at Guntakal are to be remodelled:
 - (b) if so, the reasons therefor; and

(c) the estimated cost of the scheme?

The Deputy Minister of Railways (Shri Shahnawaz Khan): (a) There is no proposal to remodel the Hospet-Guntakal line but four additional crossing stations and facilities are being provided. The yard at Guntakal is being remodelled.

- (b) The present facilities in the Guntakal Yard and the Hospet-Guntakal Section are inadequate to deal with the present traffic and the anticipated increase in traffic of iron ore from Hospet to Madras Port.
- (c) The Guntakal Yard is being remodelled at an estimated cost of Rs. 26:04 lakhs.

Sone River Barrage

*512. Shri Kamal Singh: Dr. Ram Subhag Singh:

Will the Minister of Irrigation and Power be pleased to refer to the reply given to Starred Question No. 580 on the 1st August, 1956, regarding the proposed barrage on the Sone River in the District of Shahabad, Bihar and to state:

- (a) whether the complete plan has been prepared and has been received from the Government of Bihar;
- (b) if so, the important features and estimate of cost; and
- (c) when the work is likely to be taken up?

The Minister of Irrigation and Power (Shri S. K. Patil): (a) Yes, Sir.

- (b) The salient features of the scheme are as follows:
 - (i) A new Barrage, combined with 24 ft. wide road bridge 4,752 ft. long, five miles upstream of the present Sone anicut.
 - (ii) New reaches of the left and right bank main canal with a capacity of 8,000 and 3,600 cusecs respectively.

- (iii) High level canals from both the main canals to bring, under command new areas.
- (iv) Total area to be irrigated is 17:11 lakh acres.

- (vi) Estimated cost, excluding power portion and remodelling of existing distribution system, is Rs. 13:09 crores.
- (c) The project report is under technical examination and no decision to undertake the work has yet been taken.

Howrah-Delhi Janata Express

*513. Shri H. N. Mukerjee: Will the Minister of Railways be pleased to state:

- (a) whether it is a fact that on thelst January, 1957 the 69 Up Janata Express met with an accident at Porastation of the Northern Railway;
- (b) if so, what were the casualties and how they were treated;
- (c) whether it is a fact that a relief train which carried the passengers of the said Express, including the injured, was detained for a long time at Aligarh station where there was noarrangement for relief and supply even of food; and
 - (d) if so, the reasons thereof?

The Deputy Minister of Railways. (Shri Shahnawas Khan): (a) to (d). A statement is laid on the Table of the Sabha. [See Appendix III, annexure No. 35.]

Non-Departmental Telephone Operators

The Minister in the Ministry of Transport and Communications (Shri Raj Bahadur): (a) Yes.

- (c) A memorandum was submitted in February, 1957.
- (d) It is under consideration of Government.

Vizagapatam Port

- *515. Shri R. J. Rao: Will the Minister of Transport and Communications be pleased to state:
- (a) the number of berths in the Vizagapatam port;
- (b) the number of incoming ships every week;
- (c) how long a ship has to wait outside to get a berth at the Vizagapatam port; and
- (d) in view of the fact that Vizagapatam Port is the only port for export of manganese and iron ore from States of Madhya Pradesh and Orissa, whether any steps are being taken by Government to remove the congestion and to develop the port?

The Minister of State in the Ministry of Transport and Communications (Shri Raj Bahadur): (a) 4 quay berths for over and general cargo, 3 jetty berths for bunkering, 4 mooring berths and 2 quay berths for oil tankers.

- (b) The number of incoming ships varies from time to time; the average for March and April 1957 was between 9 and 10 ships per week.
- (c) The waiting period of ships to obtain a berth also varies from time to time. For example in April 1957, when 38 ships entered the port, the waiting period averaged to 4.47 days per ship.

(d) As part of the Second Five Year Plan it is proposed to provide additional berths and mechanical equipment for handling of ores. Some equipment has already arrived and the dredging work for the additional berths is about to commence.

Indo-Pak Canal Water Dispute

- "516. Shrimati Tarkeshwari Sinha: Will the Minister of Irrigation and Power be pleased to refer to the reply given to Starred Question No. 47 on the 15th May, 1957 and state:
- (a) whether it is a fact that during the interim period of the negotiations between India and Pakistan about the canal water dispute, India is being bound not to undertake any major canal developments concerning those waters, while Pakistan is free to do so; and
- (b) what has been the cost of the Indian delegation which had virtually to stay in Washington for about five years?

The Minister of Irrigation and Power (Shri S. K. Patil): (a) No, Sir.

(b) The current phase of the cooperative work, with the participation
of the World Bank, on the Indus
Waters Dispute, was resumed in
Washington in December, 1954. While
the co-operative work has been
extended upto the 30th September
1957, the deputation of the Indian
delegation to Washington has been
sanctioned at present upto the 30th
June, 1957. The total expenditure on
the stay of the Indian delegation at
Washington from December, 1954 to
30th June, 1957, is Rs. 10-81 lakhs
approximately.

Steel Supplies for Indian Railways

*517. Shri Assar:
Shri U. L. Patil:

Will the Minister of Railways be pleased to state:

(a) whether Government have sent or propose sending special team of officers to secure supplies of steel and other materials for Railways;

- (b) if so, the names of the countries this team is visiting or will visit; and
- (c) the approximate expenditure to be incurred on this team?

The Deputy Minister of Railways (Shri Shahnawaz Khan); (a) Yes.

- (b) United Kingdom and other European countries. and possibly Japan and Canada.
 - (c) Rs. 81,000 approximately.

Shifting of Khalilabad Sugar Factory

•518. ∫ Shri Sinhasan Singh: Shri Bishwa Nath Roy:

Will the Minister of Food and Agriculture be pleased to state:

- (a) whether the Khalilabad Sugar Mill in District Basti has sought the permission and also aid of Government to shift the said factory to some other place:
- (b) if so, whether the necessary permission and aid, if any, have been granted;
- (c) whether Government have consulted the Sugar Cane growers about the proposed shifting and have considered their side of the case;
- (d) to what extent this shifting would affect the sugar-cane cultivation in that part of the District which was supplying sugar-cane to this factory; and
- (e) whether Government have taken any step to help the Sugar-cane growers to grow more and better type of sugar-cane?

Distribution of Imported Wheat

The Deputy Minister of Food and Agriculture (Shri A. M. Thomas): (a) and (b). No such telegram was received from the Roller Flour Millers Federation of India. A telegram protesting against stoppage of supply of Imported wheat was, however, received from 3 flour mills of Baroda and Ahmedahad

The mills are free to purchase indigenous wheat from any part of the country and with the arrival of the new crop wheat in the market no hardship should be experienced by them.

Mahindrughat Station

It is proposed to locate Mahindrughat Station at a new permanent site 300 yards upstream of the existing Mahindrughat Station where existing P.W.D's. Bungalow Superintending Engineer and his office is located. Negotiations for acquiring new site are already in progress. Construction of the new station building will follow the transfer of property to the Railway Administration by the State Government.

Bridge over Choti Gandaki

•525. Shri Jhulan Sinha: Will the Minister of Transport and Communi-.cations be pleased to state:

(a) the present position regarding the scheme for the construction of a bridge over the river Choti Gandaki at Guthani in Guthani P.S. to connect the two States of Bihar at Guthani and Uttar Pradesh at Lar Road; and

(b) the amount of assistance promised for the scheme by Central Government?

The Minister of State in the Ministry of Transport and Communications (Shri Rai Bahadur): (a) and (b). The bridge is estimated to cost about Rs. 8 lakhs against which the Government of Uttar Pradesh have agreed to contribute a sum of Rs. 1:50 lakhs and the Government of India have offered a grant-in-aid amounting to 1/3rd of the actual expenditure subject to a maximum of Rs. 2.67 lakhs from the Central Road Fund (Ordinary) Reserve provided the Government of Bihar are prepared to meet the balance of the cost from their own resources. The Government of Bihar who were addressed on the subject in January 1957 have not yet intimated their views.

The Minister of State in the Ministry of Transport and Communications (Shri Raj Bahadur): The assessment quoted in the I.L.O. Report is based on the findings of the Dock Workers (Regulation of Employment) Enquiry Committee and shows that the time taken in 1954 for handling 5,000 tons of cargo, brought in ships of different lines to Bombay had, as compared with 1950, increased from 26 per cent. to 75 per cent. The I.L.O. Report does not cover ports other than Bombay nor delays to shipping caused shortage of berthing capacity.
