## Kurduwadi-Micaj Raliway Line

\*729. Suri Sonawane: Will the Minister of Railways be pleased to state:

- (a) the progress made so far by the survey party on the narrow gauge line of the Central Railway between Kurduwadi and Miraj Railway Stations:

(c) and (d) In order to obtain better river crossings, flatter gradients and easier curves suited to the Broad Gauge, certain deviations from the existing alignment are under consideration. The Railway has been advised to give due consideration to suggestions for alternative alignment.
