Scheduled Castes and Scheduled Tribes

The Deputy Minister of Home Affairs (Shrimati Alva): (a) The criteria for the specification of Scheduled Castes are that they should not only be backward educationally and economically but should also be subject to tangible social disabilities based on the custom of untouchability. The criteria for the specification of Scheduled Tribes are their general backwardness, lack of acculturisation with the rest of the community, distinctive way of life, culture, etc.

(b) (i) The Constitution (Scheduled Castes) Order, 1950, (ii) the Constitution (Scheduled Castes) (Part C States) Order, 1951; (iii) the Constitution (Scheduled Tribes) Order, 1950; (iv) the Constitution (Scheduled Tribes) (Part C States) Order, 1951 and (v) The Scheduled Castes and

Scheduled Tribes Orders (Amendment) Act, 1956.
