Title: Regarding issue of notification regulating the use of RO Purifier-laid.

SHRI JAYADEV GALLA (GUNTUR): ... (Interruptions) ... * It is the responsibility of both the Central and State Governments to take measures to protect public health and environment. There have been complaints that RO systems used in India are de-mineralising water. So, Expert Committee was constituted which recommended that if TDS is less than 500 milligrams per litre, such RO system will remove important minerals and also cause undue wastage of water. ... (Interruptions)

Issue has gone before NGT and it had directed the Government of India to immediately issue notification banning RO purifiers where TDS in water is below 500 milligrams per litre. The Ministry then sought extension of time for notification due to the pandemic and NGT granted the same. The period expired, I think, in January. Government sought four more months for issue of notification – two months for inviting comments and two months for finalisation. ... (*Interruptions*)

Now, that period is over. Hence, I appeal to the Government of India to issue notification in the interest of public health. ... (*Interruptions*)
