'Land' and 'Colonization' are State subjects. This Ministry, under the vision of 'Housing for All', is supplementing the efforts of State/ Union Territory (UT) Governments by providing central assistance under Pradhan Mantri Awas Yojana- Urban (PMAY-U) for construction of houses for all eligible families/ beneficiaries since 25.06.2015. So far, based on the project proposals submitted by respective States/ UTs to this Ministry, more than 122 lakh houses involving Central assistance of₹ 2.03 lakh crore have been sanctioned under PMAY-U. During the last three financial years (2019-20 to 2021-22) and current year (2022-23), Central assistance of ₹ 1,00,318.66 crore has been sanctioned,₹ 70,697.39 crore released and ₹ 89,000.07 crore utilized; State/ UT-wise details of which are annexed.
