MOTOR VEHICLES TAXATION

The Parliamentary Secretary to the Minister of Railways and Transport (Shri Shahnawas Khan): Attention is invited to my reply to Starred Question No. 470 asked by Shri S. N. Das today.

Shri S. N. Das: May I know whether the recommendations of this Inquiry Committee were considered by the Transport Advisory Council at any time, and if so, what were the decisions of the Advisory Council?

Shri Shahnawas Khan: The decisions were considered by the Transport Advisory Council, and at present the whole matter is between the Technical Committee and the State Governments!

Shri S. N. Das: May I know when that Technical Committee was ap-pointed, and by what time it was asked to submit its report?

Shri Shahnawaz Khan: It was appointed in August 1952, and has finished its deliberations. The report will be ready by December.

Sardar Hukam Singh: May I know whether any ceiling for sales tax on petrol has been fixed according to the recommendation of this Advisory

· Shri Shahnawax Khan: As I have said before, no definite decision has yet been taken.

shri L. B. Shasiri: A Technical Committee has been appointed for the same purpose, and it has already had discussions with the representatives of several States. It is expected that they will be able to finish the maning State. by the end of ed on the end December.

Sardar Hukam Singh: But that re-commendation was made by the Ad-visory Council in April 1951. What is the reason for the delay in arriving at a decision?

Shri L. B. Shastri: No final decision

Shri L. B. Shastri: No final decision was taken, the matter was considered and discussed by the Advisory Council. The recommendations were again referred to the various States for ratifying the conclusions that were arrived at by the Council. Some of the State Governments did not agree to them, and have not ratified them And so this Technical Committee was appointed further to go into the matter, and arrive at some final decision. cision.

RURAL POST OFFICES

*471. Shri B. K. Das: Will the Minister of Communications be pleased to

(a) the number of self-supporting post offices under the "a post office for a village having two thousand and above population" S-heme;

(b) the total loss incurred on such post offices; and

(c) the total loss incurred during the first six months of this year for post offices started without any liabi-lity on the beneficiaries?

The Deputy Minister of Communications (Shri Raj Bahadur): (a) 7,798.

(b) Presumably the Member is referring to Village Post Offices which are not self-supporting. In that case the loss is Rs. 67,40,914/-/- up to the end of September 1952. (c) Rs. 20,10,631/-/-.

Shri B. K. Das: May I know the total number of post offices started under this 'a post office for a village having two thousand and above population' scheme?

Shri Raj Bahadur: At the end of eptember the number was 17,850, September, the for the villages.

Shri B. K. Das: Has the scheme been completed, or the work is still going on?

Shri Raj Bahadur: It is still going

Shri B. K. Das: How many offices are still to be started?

Shri Raj Bahadur: An exact figure is not possible because the population keeps on increasing.

Shri B. K. Das: Am I to understand

that still more post offices are to be opened in villages with a population of two thousand and above according to the latest census? Shri Raj Bahadur: Yes, they will

be opened. Shri B. K. Dgs: May I know, Sir, whether the non-returnable contribution scheme is also continuing?

Shri Raj Bahadur: It is.

Shri T. S. A. Chettiar: Among the post offices in villages with a population of 2,000, how many have turned

out to be deficit?

Shri Raj Bahadur: Deficit? The number is 10,092.

Shri N. Sreekantan Nair: May I know, Sir, out of the 8000 odd rural post offices, how many engage departmental Postmasters and how many non-departmental Postmasters?

Shri Raj Bahadur: Mostly they are extra-repartmental Postmasters.
