Inspections were made to enforce these provisions and action taken against offenders. In the light of this, no question of lack of implementation of any instruction of the Chief Inspector of Mines arises.

TIS HAZARI TELEPHONE EXCHANGE

\*716. Shri K. G. Deshmukh: Will the Minister of Communications be pleased to state:

- (a) what is the initial capacity of providing telephone lines of the new Telephone Exchange, opened in Old Delhi on the 24th January, 1953; and
- (b) whether this new Telephone Exchange will fulfil the needs of the people from that area?

The Deputy Minister of Communications (Shri Raj Bahadur): (a) 2,900 lines; the capacity will be increased to 4.000 lines by the middle of the current year.

(b) Not fully. 545 PSD GORAKHPUR-THUTHIBARI RAILWAY LINE

\*728. Shri H. S. Prasad: (a) Will the Minister of Railways be pleased to state whether the Railway Ministry have received a proposal from the Government of Uttar Pradesh for the opening of a Railway line from Gorakhpur to Thuthibari via Mahrajani?

(b) If so, do Government propose to construct the said Railway line?

The Parliamentary Secretary to the Minister of Railways and Transport (Shri Shahnawaz Khan): (a) The reply is in the affirmative.

ENFORCEMENT OF PROVIDENT FUND SCHEME

\*729. Shri K. Subrahmanyam: (a) Will the Minister of Labour be pleased to state whether Government consider embroidery mills as part and parcel of the textile industry or not?

- (b) Is it a fact that the only two embroidery mills in India are situated in Chheharta in Amritsar District?
- (c) Is it a fact that both these mills have not enforced the Provident Fund Scheme despite the repeated demands of the workers?
- (d) Is it also a fact that protests by workers to the Labour Commissioner did not also have any effect?

The Minister of Labour (Shri V. V. Giri): (a) Yes.

- (b) No. In addition to the two embroidery mills situated in Chheharta in Amritsar District, there is also one embroidery mill at Delhi.
- (c) No. It has been reported that Provident Fund schemes on the lines of the Employees' Provident Funds Scheme, 1952—but offering more liberal terms to the employees have been introduced in the embroidery mills at Chheharta and collection of provident fund contributions started from November, 1952.
  - (d) Does not arise.

TELEGRAPHIC COMMUNICATIONS IN CHITTORGARH DISTRICT

- \*730. Shri U. M. Trivedi: (a) Will the Minister of Communications be pleased to state what steps have been taken to extend telegraphic communications in Chittorgarh District?
- (b) Is it a fact that for people living in the sub-division of Begun the nearest telegraph office is at a distance of 50 miles?

(c) If so, what action do Government propose to take in the matter?

The Deputy Minister of Communications (Shri Raj Bahadur): (a) and (c). Four telegraph offices are functioning in Chittorgarh District. Proposals for providing telegraph facilities at all the tehsil headquarters are under consideration.

(b) The nearest office is at Chittorgarh, which is 36 miles from Begun.

## IN TE RESPARCH INSTITUTE

\*731. Shri Barman: Will the Minister of Food and Agriculture be pleased to state:

- (a) the amount that is spent by the Jute Research Institute on researches in the year 1952;
- (b) the nature of the researches it had pursued in 1952 and the quantum of success attained; and
- (c) how far such researches have helped the growth of finer quality of jute to supplement import from Pakistan?

The Minister of Food and Agriculture (Shri Kidwai): (a) The expenditure incurred by the Jute Research Institute during 1952-53 was as follows:—

Recurring ... Rs. 3,94,111

Non-Recurring ... Rs. 8,91,044 (including the construction of the Institute quarters and Farm structures)

- (b) and (c). During 1952 the Institute had been pursuing research on the following subjects:—
  - 1. Breeding and Genetics of jute.
  - 2. Cytogenetical investigations.
  - 3. Physiological studies,
  - 4. Jute agronomy,
  - 5. Soil and Mircrobiological studies.
  - 6. Diseases and pests,
  - 7. Substitute fibres.

Research is by its nature a long-term process and the success attained during a particular year cannot be exactly assessed. However, during 1952, certain high yielding varieties which have been found to increase the fibre yield by 15 per cent. to 39 per cent. have been evolved. Useful results have also been achieved in indicating the methods that should be followed for achieving optimum increase of jute production by early sowing, row crop-

ping, utilisation of an improved jute seed drill, double-cropping and manuring with ammonium sulphate and potash. The Institute is also carrying out researches for evolving better varieties and is investigating the cultural, manurial, harvesting, steeping and retting practices calculated to improve the quality of jute.
