The Medical Council of India will arrange for the inspection of the facilities for teaching available at the Darbhanga Medical College and attach ed hospitals for the under-graduate medical course and the standards examinations conducted at the of stitution before they recommend to Government the recognition under the Indian Medical Council Act, 1933, of the M.B.B.S, degree to be awarded by the University of Bihar.

NORTH BIHAR SUGAR FACTORIES

The Minister of Food and Agriculture (Shri Kidwai): (a) There is some accumulation of sugar stocks with North Bihar factories as is also the case with other factories in Uttar Pradesh and South Bihar.

- (b) The main reasons for accumulation of stocks are larger carry-over from the previous season, low off-take during October and November 1952 and increased production during the current season.
- (c) Sugar movement has been stepped up. Sugar factories are also being allowed freely to store their surplus stocks in outside godowns.
