*1609. Shri Vittal Rao: Will the Minister of Communications be pleased to state:

- (a) the status of the postal circle in the proposed Andhra State;

The Circle will be under a Director of Posts and Telegraphs for the present.

INDO-U. S. AIR AGREEMENT

The Deputy Minister of Communications (Shri Raj Bahadur): (a) and (b). The Indo-U. S. talks concluded on August 5, 1953. It is not possible for me at this stage to give any indication of the trend of the talks or of the conclusions reached.
