- (b) It is too early to judge the size of the current year's kharif crop as in large areas of south and Peninsular India, late kharif crops are sown in September and October and depend for their growth on winter rains.
 - (c) Does not arise.

RAILWAY ACCIDENT ON KATIHAR-LUCKNOW LINE

- *106. Shri Amjad Ali: Will the Minister of Railways be pleased to state:
- (a) whether causes of the accident in the head-on-collision between two trains on the night between the 16th and the 17th June, 1953, on the Katihar-Lucknow meter gauge line have been ascertained;
- (b) what action has been taken against the persons concerned;
 - (c) the total number of persons
 - (i) dead, and
 - (ii) injured; and
- (d) whether any compensation has been given to the families of the victims?

Secretary to The Parliamentary the Minister of Railways and Transport (Shri Shahnawaz Khan): Apparently, the question refers to the head-on-collision, between 442 Dn. Mixed and 807 Up Goods trains between Katihar and Semapur Stations on the Katihar-Lucknow Section of Eastern Railway. the North Provisional finding of the Government Inspector of Railways, who held his statutory enquiry into the accident, is that the collision was caused by the failure on the part of the Driver of 442 Dn.

- (b) The Driver was arrested and has been released on bail. He is under suspension.
 - (c) (i) Six persons died.
 - (ii) Fourteen (14) persons were grievously injured and 35 alightly.

(d) Not so far, as no claims have yet been received by the Ex Officio-Claims Commissioner.

POST OFFICE AT RAMAVARAM

- *107. Shri Vittal Rao: Will the Minister of Communications be pleased to state:
- (a) whether any representation has been received from the Singareni collieries workers' Union for converting the extra Department post office at Ramavaram Warangal District, into-Branch Post office;
