- (c) Have Government given or propose to give any alternate employment to those persons?
- (d) Are Government aware that in PEPSU unemployment had already assumed a dangerous proportion and this further retrenchment will add to the number of unemployed?

- (b) The main reasons for effecting retrenchment are: relaxation of controls and consequent abolition of Civil Supplies Department, fixation of cadrestrengths in different departments and finalization of integration of services, reorganisation of Secretariat and administrative departments and re-formation of / districts. tahsils sub-tahsils.
- (c) Yes, the Government are endeavouring to provide alternate employment.
- (d) The position regarding unemployment in PEPSU is more or less the same as in other States.

CONSTRUCTION OF ROADS IN ANDAMAN **ISLANDS**
