

The Parliamentary Secretary to the Minister of Railways and Transport (Shri Shah Nawaz Khan): (a) The restoration of the Nagrota-Joginder-nagar Section of the Kangra Valley Railway which was dismantled during the War is expected to be completed by February, 1954.

(b) The only representations received regarding the opening of new Railway Stations on the Kangra Valley Railway Section are those relating to the opening of a Station near Sullah and at Panchrukhi.

(c) It has been decided to open a station at Panchrukhi but not one near Sullah as it would be only about 3 miles from the adjoining station.

#### BONE-MEAL

\*1214. Shri Deegam: Will the Minister of Food and Agriculture be pleased to state:

(a) whether India is self-sufficient in bone-meal;

(b) what quantity of raw bones are exported annually and to what countries; and

(c) what quantity of bone-meal is annually imported and from which countries?

The Minister of Food and Agriculture (Shri Kidwai): (a) Yes, Sir.

(b) The export of raw bones is banned.

(c) Bone-meal is not imported.

#### HASSAN-MANGALORE RAILWAY LINE

\*1215. Shri Siddanajappa: (a) Will the Minister of Railways be pleased to refer to the answer given to starred question No. 1395 asked on the 18th September, 1953 and state whether preliminary survey work relating to the Hassan-Mangalore Railway line has been taken in hand?

(b) If so, what is the progress made so far?

(c) When is the survey report expected?

The Deputy Minister of Railways and Transport (Shri Alagesan): (a) Yes, Sir. A traffic survey is being carried out and an aerial survey will also be carried out very shortly. The estimate for the Engineering ground survey is under sanction.

(b) and (c). The surveys have only recently been sanctioned and it is too early to say when the reports would be available for examination.

#### RAILWAY EMPLOYEES (SENIORITY)

Will the Minister of Railways be pleased to state:

(a) whether the preparation of combined seniority lists of Class III and Class IV staff of the re-grouped Railways has been completed; and

(b) what are the main principles on which the determination of seniority is based?

The Deputy Minister of Railways and Transport (Shri Alagesan): (a) No, but the work is in progress.

(b) The main principles on which the combined seniority lists are to be drawn up are the length of service in the grade, permanent and officiating; and maintenance of *inter se* seniority in the original unit.

#### SHASTRI TRIBUNAL

The Minister of Labour (Shri V. V. Giri): There was never a vacancy among the Members of the Shastri Tribunal. It was an *ad hoc* Tribunal and ceased to exist after the Tribunal had given its main award on the 20th March 1953.
