*2191. Shri K. C. Sodhia: (a) Will the Minister of States be pleased to state whether the Education Expert Committee appointed for the re-constitution of the Osmania University has begun to function?

(b) If not, when is it likely to do sc?

The Minister of Home Affairs and States (Dr. Katju): (a) No.

(b) It is expected that the Committee will start functioning soon.

Shri K. C. Sodhia: What is the reason for the delay?

Dr. Katju: This matter was discussed during the Budget debate and then I stated that, unfortunately, the Chairwho was appointed, Acharya man Narendra Dev, was in indifferent resigned in January health and he Another Chairman Dr. Zakir Hussain was appointed. The Hyderabad Government has been asked to furnish a report or statement about their opinion. They have said that they will do so in a very short time, probably in a week or so. As soon as that statement is received, the Committee is expected to begin to function.

Dr. Suresh Chandra: May I know the reason why the Chairman of this Expert Committee resigned? May also know whether it is a fact that the idea of reconstitution has been dropped because of the opposition of the Hyderabad Government and the Osmania University?
