

DELHI EMPLOYMENT EXCHANGE

*1559. **Shri Ramji Verma:** Will the Minister of Labour be pleased to state:

(a) the number of persons employed through the Delhi Employment Exchange during the year 1952-53; and

(b) the number of people who were registered over a year ago and who have not been provided employment so far?

The Deputy Minister of Labour (**Shri Abid Ali**): (a) 7,759.

(b) On 15-2-54, 1105 such persons were on the Live Register of the Delhi Employment Exchange.

श्री राम जी वर्मा : क्या गवर्नमेंट को एम्प्लायमेंट एक्सचेंज की शिकायतें मिलती हैं और यदि मिलती हैं तो उन पर सरकार ने क्या किया है ?

श्री आबिद अली : शिकायतें सामान्य तरीके की मिलती हैं जिन पर कोई खास कार्रवाई नहीं की जा सकती है। जब खास शिकायत मिलती है तो उस पर कार्रवाई की जाती है और अगर कोई सबूत पहुंचता है तो उस पर सख्त कार्रवाई की जाती है।

JAMNAGAR INSTITUTE

*1560. **Shri Krishnacharya Joshi:** Will the Minister of Health be pleased to state:

(a) whether the Central Institute for Research in Indigenous Systems of Medicine at Jamnagar, has commenced working; and

(b) if so, the progress made during 1953?

The Deputy Minister of Health (**Shrimati Chandrasekhar**): (a) Yes, from September, 1953.

(b) It is too early at present to assess the progress so far made.

Sūri Krishnacharya Joshi: May I know how many doctors and *vaidyas* are engaged in the Central Institute and how many of them are qualified in allopathy?

Shrimati Chandrasekhar: There is a list here with me of more than twelve doctors, and, with your permission, I shall read it out.

Mr. Speaker: The hon. Member only wants the number.

Shrimati Chandrasekhar: In accordance with the recommendation of the Governing Body, the following technical staff have been appointed:

Shri Krishnacharya Joshi: May I know whether the Governing Body has submitted any report during this period?

Shrimati Chandrasekhar: They have not submitted any report. They make some recommendations about the administration.

Shri S. C. Samanta: May I know whether any change has been made in the constitution of the Governing Body recently?

Shrimati Chandrasekhar: No changes have been made.

Shri M. D. Ramasami: May I know the different systems of medicines under research?

The Minister of Health (Rajkumari Amrit Kaur): Only *Ayurved* research is carried on in Jamnagar.

WORLD FORESTRY CONGRESS

*1561. **Shri D. C. Sharma:** (a) Will the Minister of Food and Agriculture be pleased to state whether it is a fact that a World Forestry Congress is being convened at the invitation of the Government of India?

(b) How many countries will be represented at the Congress?

(c) What subjects will be discussed?

The Deputy Minister of Food and Agriculture (Shri M. V. Krishnappa): (a) The Fourth World Forestry Congress will be held in India at the invitation of the Government of India.

(b) About 80 countries.

(c) The present state of forest production and forest management in the World, the protective functions of forests, forest products utilisation, tropical forestry and other relevant matters.

Shri D. C. Sharma: May I know for how many days this Conference will last to discuss all these subjects?

Shri M. V. Krishnappa: This Conference is held once in five years and this is the fourth of the series. The previous conferences were held in Budapest and Helsinki. This is the first time that it is being held in India.

Shri D. C. Sharma: For how many days will this Conference last in order to discuss all these subjects?

Shri M. V. Krishnappa: The Conference will last from the 11th of December to the 22nd of December.

Shri D. C. Sharma: May I know, Sir, whether any attempt will be made to standardise training and education in India so far as forestry is concerned?

Shri M. V. Krishnappa: This is an international conference. I have already given a big list of the subjects that will be discussed. We shall try to include this subject also, if possible.

Shri S. N. Das: May I know whether the venue of this Congress has been fixed in New Delhi or in some forest area?

Shri M. V. Krishnappa: It will be held in Dehra Dun.

RAILWAY PASSENGER TRAFFIC

*1562. **Dr. Ram Subhag Singh:** Will the Minister of Railways be pleased to state the names of the Railways on which there was a drop in passenger traffic in the year 1953?

The Parliamentary Secretary to the Minister of Railways and Transport (Shri Shahnawaz Khan): The number of passengers booked during the nine months ending with 31st December 1953 of the current financial year indicate decline on the Central, North Eastern and Southern Railways as compared with the corresponding period of the previous year.
