new services will touch. They examined the various facilities available like accommodation for booking office aerodromes etc. and then they formulated these particular recommendations.

Sardar Hukam Singh: May I know whether they made recommendations for more than these two routes or it was only these two routes that were recommended and others were not considered suitable for plying yet?

Shri Raj Bahadur: Keeping in view the fleet of aircraft available this is what they have recommended.

FOREST RESEARCH INSTITUTE, DEHRA DUN

- *1120. Shri M. L. Dwivedi: Will the Minister of Food and Agriculture be pleased to state:
- (a) whether any arrangement has been made for the collection of statistics on research done at the Forest Research Institute, Dehra Dun, and its allied institutions; and
- (b) whether Government have considered the recommendations of the Estimates Committee (vide para. 26 on page 16 of the Committee's Sixth Report) and what steps are being taken to implement these recommendations?

The Minister of Agriculture (Dr. F. S. Deshmukh): (a) Yes.

(b) The Central Advisory Board on Forest Utilization has considered the 776 PSD recommendations and drawn the specific attention of its Executive Committee to them for implementation.

Other facilities, such as opening of new stations and additional booking windows, running of special trains, strengthening of existing trains, additional platforms, etc., were also provided

(b) No concession in fares was allowed. Facilities provided included issue of return tickets at two single journey fares, running of special trains, extension of existing services, strengthening of trains and opening of a temporary station at Congress Nagar with arrangements for reservation of seats and berths.

DRY FARMING METHODS

*1122. Shri Jhulan Sinha: Will the Minister of Food and Agriculture be pleased to state:

- (a) the areas where Dry Farming methods are being experimented upon or successfully carried on; and
- (b) the result of these experiments and operations?

The Minister of Agriculture P. S. Deshmukh): (a) As far as is known research work on dry farming is being carried on in Bombay and Madras. The results of research work already undertaken are being adopted under field conditions in the dry parts Madras, Bombay, Hyderabad. Madhya Pradesh. Bhopal, PEPSU and Vindhya Pradesh.

(b) A statement is laid on the Table of the House. [See Appendix IV, annexure No. 26.]

Shri Jhulan Sinha: May I know, Sir, if the entire initiative in the matter has been left to the States or the Central Government also takes it up?

Dr. P. S. Deshmukh: The initiative is shared by the Centre and the States.

Shri Jhulan Sinha: How much of the amount sanctioned as loan to the various States has been availed of by them?

Dr. P. S. Deshmukh: I have not got reports from them yet.

Shri Raghavachari: Is there any literature that has been published showing the results of all these researches on dry farming?

Dr. P. S. Deshmukh: I believe, Sir. Yes.

Shri Lakshmayya: May I know whether research in dry farming is being carried on in Andhra State?

Dr. P. S. Deshmukh: The State has recently come into being. I am sure 'Madras' probably includes Andhra.
