(d) whether it is under the consideration of the Australian Government to open a Trade Commissioner's office at Madras?

MOVEMENT OF POPULATION BETWEEN EAST AND WEST BENGAL

*171. Shri S. N. Das: Will the Prime Minister be pleased to state the community-wise figures of the movement of population between East and West Bengal during 1953?

The Deputy Minister of External Affairs (Shri Anil K. Chanda): The figures of movement between East Bengal and West Bengal, through various check-posts in West Bengal, during the year 1953, are as follows:—

COMMERCIAL EXPLOSIVES

*173. Shri H. N. Mukerjee: Will the Minister of Irrigation and Power be pleased to state when the Koyna Project is expected to be ready to supply power?

The Deputy Minister of Irrigation and Power (Shri Hathi): According to the estimates given by Bombay Government power is expected to be supplied by 1959-60.

PROTECTED INDUSTRIES

*174. Shrimati Renu Chakravartty: Will the Minister of Commerce and Industry be pleased to state:

(a) whether it is a fact that protected industries represented to the Tariff Commission that the liberalisation of import policy had reduced or nullified the effective protection enjoyed by them and asked for a review of the position; and

(b) if so, which are the industries and what steps have been taken to inquire into the causes of their grievances?

The Minister of Commerce and Industry (Shri T. T. Krishnamachari): (a) and (b). Since 1952 simultaneous representation_S were made to Government and the Tariff Commission by three industries viz., Soda Ash, Pencils and Electric Brass Lamp Holders. The complaints were investigated and I lay on the Table of the House a statement indicating the action taken thereon [See Appendix I, annexure No. 34.]
