WRITTEN ANSWERS TO QUESTIONS

TRANSFER OF UNION'S OFFICE-BEARERS

- *1977. Shri Raghavajah: Will the Minister of Communications be pleased to state:
- (a) whether Government have received petitions or representations from Post and Telegraph workers to the effect that office-bearers of their unions should not be transferred to other places; and
 - (b) if so, the action taken thereon?

The Minister of Communications (Shri Jagjivan Ram): (a) Yes.

(b) According to the orders the Secretary, Assistant Secretary and Treasurer of a service Union are already generally exempt from transfer during the 1st year of their election to such posts. This immunity from transfer cannot be extended to all the office bearers of the Unions. Representations against during this period are generally on merits and considered decided accordingly.

> TELEGRAPH CHECK OFFICES

- *1981. Shri Ramananda Das: Will the Minister of Communications be pleased to state:
- (a) what percentages of A, B and C drafts of telegrams are ordinarily checked in the Telegraph Offices; and
- (b) what are the percentages of missing drafts in each of the three categories of telegrams mentioned above as detected by the different check offices?

The Minister of Communications (Shri Jagjivan Ram): (a) The Telegraph Check Office, Calcutta, ensures that all 'A' message drafts as entered by the Telegraph Offices in their daily dockets, have either been received in that office or otherwise accounted for. A "test check" is also applied in regard to selected telegraph offices every month to see that no 'A' message which has been transmitted on

wires and for which therefore there are corresponding 'B' and 'C' messages, has remained unaccounted for or withheld by those offices.

The Telegraph Check Office also watches generally that the Telegraph Offices submit regularly their 'B' and 'C' messages.

No detailed check is conducted on 'B' and 'C' drafts.

(b) The percentage of missing 'A' messages detected in test check described above is as follows:-

> 1952-5305 per cent. 1953-54 ·007 per cent. (first half)

No record of missing 'B' and 'C' messages is available, since no detailed check of these categories is conducted.
