श्री गणपित राम: क्या में जान सजता हूं कि इन उम्मीदवारों में शिड्यूल्ड कास्ट के कितने केंडीडेट थे और उनके लिये मिनिमम क्यालीफिकेशन क्या रखी गयी थी ?

Dr. M. M. Das: There is no separate qualification determined for the admission of the Scheduled Caste candidates. There are two courses. One is postgraduate diploma course, open to all candidates, preferably M.A. in Modern Indian History, or History Hons. graduates with Modern Indian History as one of their special papers. Preference is given to candidates deputed by State Governments, universities, educational institutions etc.

Shri Sadhan Gupta: How many of the six candidates absorbed were given long-term training and how many of them short-term training?

Dr. M. M. Das: Out of the 33 candidates who have passed the long-term course, six candidates have been absorbed—five under the National Archives of India and one under the U.P. Government. We have got no information about the rest of the candidates. So far as the short-term course is concerned, only employees of the State Governments and Central Government are allowed to take part.

The Deputy Minister of Finance (Shri M. C. Shah): (a) The amount of

income-tax realised from Banaras District year-wise during the last five years is:

1949-50 Rs. 18,84,820.

1950-51 Rs. 23,68,053.

1951-52 Rs. 45,12,275.

1952-53 Rs. 30,48,880.

1953-54 Rs. 17,10,500.

(b) The average annual amount of income-tax realised from tobaccomerchants of the District during this period is Rs. 1,16,135.

श्री रूप नारायण : क्या में जान सकता हूं कि अभी तक कितना इनकमटैक्स वसूल नहीं हुआ है और फितने सालों से ?

Shri M. C. Shah: I cannot give those figures, because...

Mr. Speaker: The hon. Member may table a separate question.

श्री रूप नारायणे: क्या में जान सकता हूं कि बनारस का इनकमटैक्स देने में कौनसा नम्बर है ?

Shri M. C. Shah: I do not have district-wise figures for the whole State. If he wants them, then he must give me notice of a separate question.

Dr. Rama Rao: May I know how much of this income-tax has been realised as a result of the efforts of the Income-tax Investigation Commission?

Shri M. C. Shah: There is another specific question with regard to the Income-tax Investigation Commission. Perhaps, the hon. Member is referring to that. I can give those figures. The amount of income-tax assessed is Rs. 25.80 crores, and the amount already realised is Rs. 9.62 crores.

Mr. Speaker: Does this refer to Banaras District?

Shri M. C. Shah: He is referring to the Income-tax Investigation Commission. Mr. Speaker: The hon. Member's question is how much of this tax has been realised from Banaras District, as a result of the effort of the Incometax Investigation Commission.

Shri M. C. Shah: I have not got those figures with me now.

Shri Altekar: May I know the reasons why so small a sum was recovered in 1953-54?

Shri M. C. Shah: In 1951-52, there was a drive to clear off all the arrears, and therefore we got a higher sum. In 1953-54, the smaller sum may be due to lesser profits.

Shri Ganpati Ram: May I know the total number of tax-payers?

Mr. Speaker: Order, order. Next question.

HINDUSTANI CULTURE SOCIETY, ALLA-HABAD

- *2101. Shri M. L. Agrawal: Will the Minister of Education be pleased to state:
- (a) whether Government have been subsidizing a Monthly Magazine published under the auspices of the Hindustani Culture Society of Allahabad;
 - (b) if so, since when; and
- (c) the amounts paid every year from the beginning up-to-date?

The Parliamentary Secretary to the Minister of Education (Dr. M. M. Das): (a) No subsidy has been given to the monthly magazine published by the Hindustani Culture Society.

(b) and (c). Do not arise.

Dr. M. M. Das: During the years 1946-1951, we have paid to this Society, a sum of Rs. 1,12,000, for their publication programme.

- Shri S. N. Das: May I know whether at the time of asking for the grant, this organisation has specified the objects for which it wanted the grant?
- Dr. M. M. Das: Before the grants are sanctioned, some important information regarding the organisation are sought for by the Department, and unless those informations are received, no grant is sanctioned.

श्री भागवत झा आजाद: मैं यह जानना चाहता हूं कि जो अभी आपने बताया कि एक खास स्पेक्षिफिक परपत्र के लिये यह एक लाख और कुछ हजार रुपये की ग्रान्ट दी गई है, तो वह कौन से स्पेक्षिफिक परपज थे?

Dr. M. M. Das: There was no specific purpose for the Rs. 1,12,000, which I have mentioned. These grants-in-aid were given for the implementation of their publication programme.
