GRANT FROM ALL INDIA KHADI AND VIL-LAGE INDUSTRIES BOARD

- *847. Shri S. V. L. Narasimham: Will the Minister of Commerce and Industry be pleased to state:
- (a) the names of the producers of Khadi who receive grants from the All India Khadi and Village Industries Board; and
- (b) the steps that Government propose to take to give rebate to purchasers of Khadi from any producer?

The Minister of Commerce and Industry (Shri T. T. Krishnamachari):
(a) A statement is laid on the Table of the House. [See Appendix V, annexure No. 8.]

- (b) A rebate of annas three per rupee is already being given on the sale of khadi. In order, however, to ensure that rebate is given only on genuine khadi, retail purchases only from certified producers and bhandars are made eligible for this concession.
- Shri S. V. L. Narasimham: May I know the authority that is to certify about the bona fide retailers?
- Shri T. T. Krishnamachari: The authorities are those nominated by the All India Khadi and Industries Board and they are the body that have taken over the All India Spinners Association.
- Shri S. V. L. Narasimham: May I know whether it is not a fact that there are producers who have nothing to do with the All India Spinners Association?
- Shri T. T. Krishnamachari: There may be producers, but the certifying authorities need not have anything to do with the All India Spinners Association.

Babu Ramnarayan Singh! What is the increase in the production and sale of khadi after the rebate is allowed?

Shri T. T. Krishnamachari: 1 believe, I gave the information, Sir. The increase is in the region of about 17 per cent.
