

### दमिश्क में अन्तर्राष्ट्रीय मेला

\*८५२. श्री जी० एल० चौधरी : क्या चाणिज्य तथा उद्योग मंत्री यह बताने की कृपा करेंगे :

(क) क्या भारत दमिश्क में होने वाले अन्तर्राष्ट्रीय मेले में भाग लेगा; और

(ख) यदि हां, तो मेले में प्रदर्शन के लिये कौन-कौन सी वस्तुएं भेजी जायेंगी ?

**The Minister of Commerce and Industry (Shri T. T. Krishnamachari):** (a) Yes, Sir.

(b) A statement is laid on the Table of the House. [See Appendix V, annexure No. 10.]

**Shri G. L. Chaudhary:** May I know the criteria on which the selection is made?

**Shri T. T. Krishnamachari:** For selection of what, the place or the exhibits?

**Mr. Speaker:** Selection of exhibits, I think.

**Shri T. T. Krishnamachari:** The idea is to have regard to the experience gained from the other exhibitions and also the willingness of the parties to spare exhibits for the purpose of exhibiting in such a fair.

### INDUSTRIAL HOUSING IN MADHYA PRADESH

\*853. **Shri N. A. Borkar:** Will the Minister of Works, Housing and Supply be pleased to state:

(a) the total amount allotted to Madhya Pradesh under the Industrial Housing Scheme during the last three years by the Central Government;

(b) whether the amounts sanctioned were fully utilised;

(c) whether it is a fact that only one hundred Houses for the Industrial workers have been constructed in Madhya Pradesh so far; and

(d) if so, the reasons therefor?

**The Minister of Works, Housing and Supply (Sardar Swaran Singh):** (a) A total amount of Rs. 30,06,500 has been sanctioned during the years 1951-52 to 1953-54.

(b) No, Sir; Not yet.

(c) Construction of 164 houses has been completed upto end of August, 1954. Another 590 houses are under various stages of construction.

(d) The somewhat slow progress is due mainly to difficulties in acquiring land.

**सरदार ए० एस० सहाय :** क्या मैं जान सकता हूँ कि मध्य प्रदेश सरकार को जो रकम खर्च करने के लिये दी गई थी वह पूरी की पूरी रकम मध्य प्रदेश की सरकार ने खर्च की है या उस में से कुछ बाकी है ?

### NEW MEDIUM-WAVE TRANSMITTERS

\*854. **Shri Raghuramaiah:** Will the Minister of Information and Broadcasting be pleased to state:

(a) whether it is proposed to install new medium-wave transmitters at different stations in India; and

(b) if so, the details of the programme including the date by which the new transmitter is proposed to be installed in each case?

**The Minister of Information and Broadcasting (Dr. Keskar):** (a) Yes, Sir.

(b) A statement giving the requisite information has been laid on the Table of the House. [See Appendix V, annexure No. 11.]

**Shri Raghuramaiah:** I find from the statement that different power transmitters have to be installed at different places. In Bangalore, a 50 K.W. transmitter is to be installed, but in Vijayawada, the area of which is not less than that of Bangalore, the transmitter to be installed is a 20 K.W. May I know the guiding principle for this differential treatment?
