LOCAL DEVELOPMENT WORKS PROGRAMME

\*845. Shri Viswanatha Reddy: Will the Minister of Planning be pleased to state:

- (a) whether it is a fact that direct assistance by the Planning Commission to the local development works programme has been stopped; and
  - (b) if so, the reasons therefor?

The Deputy Minister of Planning (Shri S. N. Mishra): (a) and (b). The budgeted provisions for local development works for amounting to Rs. 6 crores has been allocated to the State Governments without retaining any reserve with Centre on the basis that sponsors of local development works should take the fullest possible advantage of financial provisions for the local development works programme operated by the State Governments from the Central allocations. Central assistance may however be considered for any schemes which, for special reasons, may be sent direct to the Central Government particularly those sponsored by all India bodies like the Bharat Sevak Samaj etc.

\*846. Shri C. R. Chowdary: Will the Minister of Planning be pleased to state:

(a) whether any ceiling as to cost of an irrigation project to be placed in the Second Five Year Plan has been fixed; and

(b) if so, whether this principle of ceiling will be made applicable to new projects mentioned in the First Five Year Plan?

The Deputy Minister of Planning (Shri S. N. Mishra): (a) No, Sir.

## BORDER INCIDENTS

- (a) whether the Government of Pakistan have punished the culprits and paid compensation to the heirs of the Indian National who was killed by the Pakistani Policemen;
  - (b) if not, the reasons therefor?

The Deputy Minister of External Affairs (Shri Anil K. Chanda): (a) and (b). The Government of Pakistan have suggested that the incident may be jointly enquired into by a representative each of the Governments of India and Pakistan. The suggestion has been accepted and the joint enquiry is likely to take place shortly. Apparently, the question of punishing the Pakistani Policemen and of paying compensation to the heirs of the victim will be considered by the Pakistan Government after the proposed joint enquiry.
