Sardar Majithia: I have already answered that question sametime previously, that whatever decisions were taken, as a result of those, instructions have been issued to the Cantonment Boards liberalising their powers and now the Civil Area Committees are practically autonomous.

Shri A. M. Thomas: It appears that as long ago as 1943, the recommendations of a Special Committee were circulated among the States. May I know whether any report has been called for from the States, whether the recommendations have been implemented and as to whether Government are aware that the defects pointed out still exist?

Dr. M. M. Das: No report has been called for from the States. I may submit that the State Governments are the competent authorities in this matter.

Shri S. N. Das: May I know which of the States have been found guilty of this action?

Dr. M. M. Das: This is a matter for the State Governments.

CHAIRS ON Yogic PHYSICAL CULTURE

- \*964. Babu Ramnarayan Singh: Will the Minister of Education be pleased to refer to the reply given to Starred Question No. 1290 asked on the 22nd December, 1953 and state:
- (a) whether Government have since considered the question of creating chairs on vogic physical culture in the Universities to promote yogic physical culture;
- (b) if so, what are the decisions taken:
- (c) whether the finalised report of the sub-committee set up by the Advisory Board of Physical Education has been examined; and
- (d) if so, what are the findings of the committee?

The Parliamentary Secretary to the Minister of Education (Dr. M. M. Das): (a) and (b). The present position regarding the employment of Yogic Physical Culturists in Universities is being ascertained from them. When full information is collected it will be placed for consideration at the next meeting of the Central Advisory Board of Physical Education and Recreation.

(c) and (d). It is being examined in the Ministry of Education and will be put up before the Central Advisory Board of Physical Education and Recreation for its final examination at its next meeting.
