progress reports on the work done at the institute are scrutinised by the Indian Council of Agricultural Research, and guidance given.

Shri Sanganna: May I know whether any officer of the Government of India has ever inspected this institute and if so, what is his impression about the working of this institute?

Dr. P. S. Deshmukh: I must ask for notice of this question, Sir.

Shri Sanganna: May I know what benefits have been reaped from this Turmeric Research Institute and what arrangements have been for extension of services from this institute?

Dr. P. S. Deshmukh: It is always our aim to translate the results of scientific investigation for better plantation and better looking after of agricultural processes; but I cannot say what exactly has been done.

Shri Sanganna: May I know whether any progress reports have been received by Government, and if so, what are the reactions of Government in respect of these?

Dr. P. S. Deshmukh: As has been stated in my reply, we have got progress reports from time to time and we have no reason to believe that they are unsatisfactory.

## रेलवे में भाष्ट्राचार

\*१२३०. श्री पी० एल० बारूपाल: क्या रेलवे मंत्री यह बताने की कृपा करेंगे कि:

- (क) क्या कुछ ऐसे मामले पकड़े गये हैं, जिनमें टिकट चैकरों और अन्य रेलवे कर्मचारियों ने पैसे स्वयं हड़पने के प्रयोजन से यात्रियों को बिना टिकट बैटा लिया हो: और
- (ख) यदि हां, तो ऐसे मामलों में कितने कर्म बारी पकड़े गये और उनको क्या सजा दी गयी?

The Parliamentary Secretary to the Minister of Railways and Transport (Shri Shahnawaz Khan): (a) Yes. (b) During the year 1953, 21 such cases were detected on the Eastern. North-Eastern, Northern, Southern and Western Railways. Suitable disciplinary action has already been taken in twelve cases. The charges have not been proved in two cases and further investigation is progressing in regard to others. So far as the Central Railway is concerned, the information is under collection and will be placed on the Table of the House, on receipt.

श्री पी० एस० बारूबास : में जान सकता हूं कि क्या यह सही नहीं हैं कि दिल्ली आदि प्रमुख स्थानों से जाने वाली गाहियों के डिब्बों पर रंलवे कर्मचारी खिह्या से "सुरीचत स्थान" एंसा लिख कर यात्रियों को धोखा इंते हैं और गाहियों के चलने के कुछ देर पहले ही यात्रियों से पैसा लेकर बैठा दंते हैं ?

श्री शाहनवाज कां: यह बात अभी तक हमारं इल्म में नहीं हैं।

Diwan Raghavendra Rao: May I know if Government are aware that the co-sharers of these Ticket Checkers are found in Station Masters, Guards and railway police, and how Government try to find out these people?

Shri Shahnawaz Khan: As I have just stated, 21 cases have come to our notice and we are taking very severe disciplinary action against them.
