The Deputy Minister of Railways and Transport (Shri Alagesan): (a) No orders have been placed as yet. Only global quotations have, so far, been invited and offers are to be received during November and December, 1954. No accurate information about receipt of equipment can, therefore, be given at present. Some minor preliminary works have already been started.
