(b) As the payment of the grants to the State Government will depend on the actual expenditure incurred on each item, as verified by the Audit Department, the question of exercising any special check does not arise.

## LOAN TO ANDHRA

The Deputy Minister of Defence (Shri Satish Chandra): (a) 8,124.

- (b) Out of 782 persons entitled to gratuity, 303 have been paid so far.
- (c) The main reasons for the delay are:
  - (i) lack of information regarding the whereabouts of the entitled persons; and
  - (ii) time taken in verification of claims.
- (d) Efforts are being made to ascertain the last-known addresses of the individuals and instructions have been issued to all concerned to speed up disposal of the outstanding claims.
