STERLING BALANCES

*727. Shri D. C. Sharma: Will the Minister of Finance be pleased to state the manner in which the Sterling Balances have been utilised so far during 1954-55?

The Deputy Minister of Finance (Shri M. C. Shah): Sterling balances are utilised for financing the over-all deficit in India's external accounts. The sterling balances have been drawn down to the extent of about Rs. 32 crores between the end of March 1954 and end of November, 1954. Preliminary figures for the quarter ending 30th June, 1954, show a current account deficit in the balance of payments of the order of Rs. 17 crores. Balance of payments figures after 30th June, 1954, have not yet become available.

PENSIONS

***728. Shri Bahadur Singh:** Will the Minister of Finance be pleased to state:

(a) whether it is a fact that considerable delay occurs in deciding the pension payable to retiring Government officials;

(b) the number of cases in the last five years which took over three years for determining the amount of pension payable; and

(c) if the answer to part (a) above be in the affirmative, what steps Government will take in this regard?

The Deputy Minister of Finance (Shri M. C. Shah): (a) and (c). It is not a fact that considerable delay occurs in sanctioning generally pensions to retiring Government ser-There have however been vants. cases in which some delay has occurred due mainly to difficulty in verifying particulars of past service of retiring Government servants. In cases where considerable delay is expected an anticipatory pension is usually sanctioned on a provisional basis to avoid hardship.

To expedite sanctions to pensions, it has been decided that officers may submit their pension applications one year in advance of the date of their retirement so that necessary formalities and verification connected with the disposal of their pension papers may be completed before the due date.

(b) The requisite information will have to be collected from the various pension sanctioning authorities throughout the country. It is considered that the labour and time involved in doing so will be disproportionate to the result achieved.

STAFF COMMITTEES

*730. Pandit D. N. Tiwary: Will the Minister of Home Affairs be pleased to state:

(a) whether Staff Committees in various Ministries have been set up; and

(b) if so, what has been the method of selection?

The Deputy Minister of Home Affairs (Shri Datar): (a) Staff Committees have been set up in many of the Ministries. Others have taken up the question and the Committees will be formed soon.

(b) A copy of the instructions issued is placed on the Table of the House. [See Appendix III, annexure No. 68.] Each Staff Committee consists of a Chairman, representatives of Government and of the Staff. Representatives of Government are nominated by the Ministry while representatives of staff are elected by members of each grade of staff.

(c) the total value of the goods seized during these years; and

The Deputy Minister of Finance (Shri A. C. Guha): (a) There are 8 Land Customs Stations and 16 land Custom Preventive Check posts on the Punjab section of the Indo-Pakistan border.

(b) 196 and 192 cases of smuggling were detected during 1952-53 and 1953-54 respectively on this sector of the border.

(c) The total value of the goods seized on this sector of the border during 1952-53 and 1953-54 was Rs. 1,03,675 and Rs. 1,66,270 respectively.

(d) The principal commodities seized while being smuggled through this border were Gold and Silver thread, Art-silk, Muslin cloth, Black pepper, Cardamoms, Cloves, Gold, Silver and Silver-coins.
