SUBSISTENCE ALLOWANCES

*1070. Shri Tushar Chatterjea: Will the Minister of Defence be pleased to state:

- (a) whether it is a act that there is a difference in the treatment of industrial and non-industrial employees regarding payment of pay and allowances during suspension period after their re-instatement; and
 - (b) if so, 'he reasons therefor?

The Deput Minister of Defence (Shri Satish Chandra): (a) Yes.

(b) The distinction between the and non-industrial Industrial employees in the matter of grant of subsistence allowance during suspension is due to the fact that different terms and conditions of service have been prescribed for different gories of Government personnel depending on the nature of their ployment.

Minister of The Deputy Home Affairs (Shri . Datar): The Census figures related only to the Scheduled Areas of the Dungarpur District, while those of 1941 related to the whole District.

NATIONAL VOLUNTEER FORCE TRAINING

*1076. Shri Brokmo-Choudhury: Will the Minister of Defence be pleased to state whether Government have taken any steps to organise an Auxiliary Territorial Force or National Volunteer Force Training Camp for Members of Parliament and of State Regislatures?

The Deputy Minister of Defence (Sardar Majithia): The hon. Member is aware that Members of the Sabha and Rajya Sabha have been invited to volunteer for military training, if they are below 50 years and are medically fit. A copy of the letter addressed in this connection is placed on the Table of the House. [See Appendix V, annexure No. 6.] Members of the Delhi State Legislature have also been invited. About Members have so far volunteered for training and I am afraid that number does not justify the opening of a training camp which is designed to impart training for about persons. There is at present no proposal to have special camps for mem. hers of other State Legislatures.
