50 block grants were being given by the Central Government to State Governments for all development pur-poses and the amount given for Pri-mary Education alone is not readily available in 1949-50. a sum Rs. 2,60,000 was given as grant to U.P. for the training of Basic Schools Teachers.

MILITARY VEHICLES

- *1409. Shri Pataskar: Will the Minister of Defence be pleased to state:
- (a) whether it is a fact that a very large number of motor vehicles or their Bodies of various Military types are lying in open near Dehu Road in Bombay State:
- (b) the number of such vehicles and their Bodies:
- (c) the initial value of these vehicles;
- (d) the period during which they are lying exposed to sun and rain;
- (e) whether they are capable being used for military purposes; of
- (f) whether any steps were taken to preserve them from deterioration by exposure; and

The Minister of Defence Gopalaswami): (a) Yes. (Shri

- (b) It is not in the public interest to give this information.
- (c) and (d). The information is not available and its collection would entail labour and time to an extent which would not be commensurate with the utility or public interest of the information. The number varies from time to time, as vehicles are taken out for service or for better storage. A steadily increasing number of service-able vehicles is being found covered accommodation.
- (e) Vehicles not required for military purposes or no longer in suitable

- condition are declared for disposal from time to time.
- (f) There is lack of suitable accommodation but steps are taken to prevent deterioration to the maximum extent possible and most of the vehicles are covered by tarpaulins. Suitable accommodation is also being built subject to limitation of material and finance
- (g) Unserviceable vehicles which are considered beyond economical repairs and which are surplus to requirements are disposed of from time to time.

AUDIO-VISUAL EDUCATION

- *1410. Shri M. L. Dwivedi: Will the Minister of Education be pleased to
- (a) the actions taken by the Central and State Governments in connection with the implementation of the recommendations of the All India Audio-Visual Education Conference Conference held in October, 1951; and

Generally speaking, all the State Governments from whom we have heard so far are trying to implement the recommendations as far as their financial and other resources permit. The Cen-tral Government is examining the question of constituting a "National Committee on Audio-Visual Education" as recommended by the Conference.

ARCHITECTURAL MONUMENTS AT KONARKA

- (a) the salient recommendations of (a) the salient recommendations of the committee, set up with Sri Biswa-nath Das as Chairman, to suggest steps for the better preservation of the unique Architectural Monument at Konarka, in Orissa and for provi-sion of better facilities to the visitors;
- (b) which of the recommendations have so far been implemented?

- The Minister of Education and Natural Resources and Scientific Research (Maulana Azad): (a) The salient recommendations of the Committee are—
- (i) Application of chemical preservatives to the Temple for protection against salt.
- (ii) plantation of trees around the Temple for protection against sand, and
- (iii) application of water-tightening measures both inside and outside the temple.

The Committee also recommended that an all-weather road from Bhubaneswar to Konarka should be constructed and provision should be made for lodging and boarding within the Konarka area for the benefit of tourists.

(b) Experiments with chemical preservatives are being carried out and humidity tests are being taken. Steps are being taken to implement the other recommendations.

As regards construction of the road, the Government of India are in correspondence with the State Government.

PRESIDENTIAL AND VICE-PRESIDENTIAL ELECTIONS

- *1412. Shri S. N. Das: Will the Minister of Law be pleased to state:
- (a) the total expenditure incurred by Government in connection with the election of the President of the Indian Union;
- (b) whether any expenditure was incurred in connection with the election of the Vice-President; and
- (c) if the answer to part (b) above be in the affirmative, what was the amount of such expenditure?

The Minister of Law and Minority Affairs (Shri Biswas): (a) to (c). Expenditure has been incurred by the Election Commission in connection with the Presidential and Vice-Presidential elections only on the purchase of 38 special ballot boxes for the former and 4 for the latter, election. The expenditure incurred on this account on the Presidential election was Rs. 3,116 and in respect of the Vice-Presidential election Rs. 328.

Ballot papers for the Presidential election were printed at the Government of India Press gratis. The cost on this account will be met out of the grant of the Government of India Presses. Government has no information as to the exact amount spent on this account.

In addition, expenditure has been incurred by the different State Governments in the actual conduct of the poll and in the despatch of the ballot boxes to the Returning Officer at New Delhi. Here again, Government has no information as to the amount spent by the various State Governments.
